

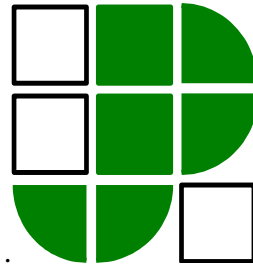

**NOTIFICATION OF PROPOSED TOWNSHIP ESTABLISHMENT: A CERTAIN PORTION (PORTION 26) OF REMAINDER OF THE FARM EKANGALA 610-JR (PROPOSED EKANGALA-G EXTENSION 2).**

The firm has applied to the City of Tshwane Metropolitan Municipality on behalf of the registered owners, for the establishment of a township in terms of Section 16(4) of the City of Tshwane Land Use Management Bylaw, 2016 read with the provisions of the Spatial Planning and Land Use Management Act, 2013 (Act 16 of 2013) of the above-mentioned property, to be known as Ekangala-G Extension 2. The purpose of the application is to procure the necessary use-rights to establish and operate a community shopping centre of approximately 15 000m<sup>2</sup> on the property.

Section 16(1)(i) of the Bylaw requires that the application be referred for comment to *inter alia* yourselves, for which you will find enclosed a copy of the motivating memorandum (excluding Annexures) as submitted to the Municipality. Kindly note that your comments must be submitted within a period of 60 days from date of this letter in terms of Section 16(1)(iv) of the Bylaw. Should you require additional time, please apply to this office in writing for an extension. **Should no reply be received within the 60-day period, it will be assumed that you have no comment.**
