**NOTICE OF WASTE MANAGEMENT LICENCE: DMS POWDERS
WASTE MANAGEMENT FACILITY – HAZARDOUS WASTE
REUSE, RECYCLING AND RECOVERY**

You are hereby notified that the National Department of Environmental Affairs (DEA) has decided to grant a Waste Management Licence for the above mentioned project in terms of the powers vested in it by the National Environmental Management: Waste Act, 2008 (Act No. 59 of 2008) and the Environmental Impact Assessment Regulations, 2010. The decision on the Waste Management Licence application was signed and issued by DEA on the 8th of June 2015. In terms of regulation 4(2) of the Environmental Impact Assessment (EIA) Regulations, 2014, all registered interested and affected parties must be notified within 14 calendar days of the Department's decision in respect of this Waste Management Licence Application as well as the provisions regarding the making of appeals that are provided for in the regulations.

In accordance with Chapter 2 of the National Appeal Regulations, 2014 (GN 993), should you wish to appeal any aspect of the decision of granting the Waste Management Licence, you must submit the appeal to the appeal administrator for the National Department of Environmental Affairs, and a copy of the appeal must be submitted to the applicant, any registered interested and affected party and any organ of state with interest in the matter, within 20 days from the date that the notification for an application for an environmental authorisation or a waste management licence was sent to the registered and affected parties by the applicant. In other words, **within 20 days from the date of this letter**, by means of one of the following methods, for the attention of The Minister: Department of Environmental Affairs:

- By post: Private Bag X447, Pretoria 0001
- By facsimile: 012 359 3625; or
- By hand: Environmental House, 473 Steve Biko Road, Pretoria, 0002.

The expiry date for the submission of the appeal to DEA is therefore **6 July 2015**.

The appeal submission must be-

1. Submitted in writing in the form obtainable from the appeal administrator; and
2. Accompanied by-
 - A statement setting out the grounds of the appeal;
 - Supporting documentation which is referred to in the appeal submission; and
 - A statement, including supporting documentation, by the appellant to confirm compliance with regulation 4(1) of the Appeal Regulations.
