NOTICE OF INTEGRATED **ENVIRONMENTAL AUTHORISATION:** VAPOROX WASTE TYRE PYROLYSIS PLANT, INCLUDING STORAGE OF DANGEROUS GOODS (APPROXIMATELY 500m3 OF OIL, ±5 TONS OF CHEMICALS, SUCH AS CATALYSTS, AND 46 CUBIC TONS OF LIQUEFIED PETROLEUM GAS) AND THE RELEASE OF EMISSIONS FROM **PYROLYSIS** PLANT THAT WILL REQUIRE THE **ATMOSPHERIC EMISSION** LICENSE (LISTED **ACTIVITY** NUMBERS 3, 5 AND 26 IN GN. NO. R.545); AND THE VAPOROX WASTE TYRE PYROLYSIS PLANT WASTE MANAGEMENT LICENCE APPLICATION (LISTED ACTIVITY NUMBERS CATEGORY A: 2, 3, 5 AND 12 IN GN. NO. R921) ON PORTION 0 OF ERF 37, BODIRELO TOWNSHIP, MOSES KOTANE LOCAL MUNICIPALITY, NORTH WEST PROVINCE

You are hereby notified that the North West Department of Rural, Environmental and Agricultural Development (NWREAD) has decided to grant an Integrated Environmental Authorisation for the above mentioned projects in terms of the powers vested in it by the National Environmental Management: Waste Act, 2008 (Act No. 59 of 2008), the National Environmental Management Act, 1998 (Act No. 107 of 1998) and the Environmental Impact Assessment Regulations, 2010. The decision to grant the Integrated Environmental Authorisation was signed by the NWREAD on the 3<sup>rd</sup> of August 2015 and issued on the 5<sup>th</sup> of August 2015. In terms of regulation 10(2) of the Environmental Impact Assessment (EIA) Regulations, 2010, all registered interested and affected parties must be notified within 12 calendar days of the Department's decision in respect of this integrated environmental authorisation as well as the provisions regarding the making of appeals that are provided for in the regulations.

In accordance with Chapter 7 of the EIA regulations (Government Notice No. R. 543 of 18 June 2010), should you wish to appeal any aspect of the decision of granting the integrated environmental authorisation, you must, *inter alia*, lodge a notice of intention to appeal with the Member of the Executive Council (MEC) for the North West Department of Rural, Environmental and Agricultural Development, within 20 days after the date of the decision, by means of one of the following methods:

- By facsimile: 018 384 2679;
- By post: Private Bag X2039, Mmabatho, 2735; or
- By hand: Cnr. Dr. James Moroko and Stadium Road, Mmabatho, 2735. Telephone number: 018 389 5688/5056.

The expiry date for the submission of the appeal to the NWREAD is therefore **26 August 2015**. In the event of appealing , you must provide the applicant, Vaporox (Pty) Ltd, within ten (10) days of having lodged the notice contemplated in subregulation (1) with –

- A copy of the notice referred to in subregulation (1) (namely the Notice of Intention to Appeal); and
- A notice indicating where and for what period the appeal submission will be available for inspection by the applicant.

The MEC may, in writing, on good cause extend the period within which a notice of intention to appeal must be submitted. The appeal must be lodged with the appeal authority within thirty (30) days of the lapsing of the twenty (20) days after the date of the decision.

The appeal submission must be-

- 1. Submitted in writing; and
- 2. Accompanied by-
  - A statement setting out the grounds of the appeal;
  - Supporting documentation which is referred to in the appeal submission and which is not in possession of the MEC as an appeal authority;
  - A statement by the appellant that Regulation 60(2) or (3) has been complied with together with copies of the notices referred to in that Regulation; and
  - The prescribed appeal fee, if any.
