You are hereby notified that the Mpumalanga Department of Agriculture, Rural Development, Land and Environmental Affairs (MDARDLEA) has decided to grant Environmental Authorisation of the above mentioned project in terms of the powers vested in it by the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended, and the Environmental Impact Assessment Regulations, 2014, as amended.

In accordance with Chapter 2 of the National Appeal Regulations, 2014, should you wish to appeal any aspect of the decision of granting the environmental authorisation amendment, you must submit the appeal to the appeal administrator of the Mpumalanga Department of Agriculture, Rural Development, Land and Environmental Affairs, and a copy of the appeal must be submitted to the applicant, any registered interested and affected party and any organ of state with interest in the matter within 20 days from the date that the notification of the decision for an application for an environmental authorisation was sent to the registered interested and affected parties by the applicant. In other words, within **20 days from the date of this letter** by means of one of the following methods:

- By facsimile: 013 766 8295;
- By post: Private Bag X11219, Nelspruit 1200; or
- By hand: Building 6, No 7 Government Boulevard, Riverside Park, Nelspruit, 1200.

The decision by MDARDLEA was signed on the 6<sup>th</sup> of May 2016 but the decision was only received by the applicant on the 23<sup>rd</sup> of May 2016. The expiry date for the submission of the appeal to be submitted to MDARDLEA is therefore **15 June 2016**
