Your registration as an Interested and Affected Party for the above project refers: You are hereby notified that the Limpopo Department of Economic Development, Environment and Tourism (LEDET) has decided to grant Amendment of the Environmental Authorisation for the above mentioned project in terms of the powers vested in it by the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended, and the Environmental Impact Assessment Regulations, 2014. The decision to grant the amendment was signed on the 26<sup>th</sup> of October 2017 and was issued to the applicant on the 30<sup>th</sup> of October 2017.

In terms of Chapter 2 of the National Appeal Regulations, 2014, all interested and affected parties must be notified within 14 calendar days of the Department's decision in respect of this Environmental Authorisation Application as well as the provisions regarding the making of appeals that are provided for in the regulations.

In accordance with Chapter 2 of the National Appeal Regulations (Government Notice No. R.993 of 8 December 2014), should you wish to appeal any aspect of the decision of granting the Environmental Authorisation, you must submit the appeal to the Appeals Administrator for the Limpopo Department of Economic Development, Environment and Tourism (LEDET), and a copy of the appeal must be submitted to the applicant, any registered interested and affected party and any organ of state with interest in the matter, within 20 days from the date that the notification of the decision of an application

for an environmental authorisation. The expiry date for the submission of the appeal to the LEDET is therefore the **27**<sup>th</sup> of **November 2017**.

An appeal submission must be-

- (a) Submitted in writing in the form obtainable from the appeal administrator; and
- (b) Accompanied by-
  - (i) A statement setting out the grounds of appeal'
  - (ii) Supporting documentation which is referred to in the appeal submission; and
  - (iii) A statement, including supporting documentation, by the appellant to confirm compliance with regulation 4(1) of these Regulations.
