NOTIFICATION OF AMENDMENT OF WASTE MANAGEMENT LICENCE: WASTE MANAGEMENT LICENCE FOR THE PROPOSED KWAGGASRAND RECYCLING FACILITY UPGRADE PROJECT FOR NEW GX ENVIRO SOLUTIONS AND LOGISTICS HOLDINGS (PTY) LTD

You are hereby notified that the Gauteng Department of Agriculture and Rural Development (GDARD) has decided to grant Amendment of the Waste Management Licence (Gaut: 002/14-15/W0015), dated 31 March 2016, for the above mentioned project in terms of the powers vested in it by the National Environmental Management: Waste Act, 2008 (Act No. 59 of 2008) and the Environmental Impact Assessment Regulations, 2014. The decision to grant the Waste Management Licence was signed by the GDARD on the 14th of September 2017 and issued on the 24th of October 2017. In terms of regulation 4(2) of the Environmental Impact Assessment (EIA) Regulations, 2014, all registered interested and affected parties must be notified within 14 calendar days of the Department's decision in respect of the amendment of this Waste Management Licence Application as well as the provisions regarding the making of appeals that are provided for in the regulations.

In accordance with Chapter 2 of the National Appeal Regulations (Government Notice No. R. 993 of 8 December 2014), should you wish to appeal any aspect of the decision of granting the Waste Management Licence, you must submit the appeal to The Appeals Administrator for the Gauteng Department of Agriculture and Rural Development, and a copy of the appeal must be submitted to the applicant, any registered interested and affected party and any organ of state with interest in the matter, within 20 days from the date that the notification of the decision of an application for an environmental authorisation or a waste management licence was sent to the registered interested and affected parties by the applicant. In other words, within 20 days from the date of this letter, by means of one of the following methods:
