

BACKGROUND INFORMATION

De Beers Consolidated Mines (DBCM) holds a marine diamond mining right in the South Africa Sea Areas (SASA), MPT 25/2011, previously known as ML3/2003 (ML3). The mining licence area is situated some 500 km north of Cape Town, with the inshore boundary 5 km seaward of the coastal towns of Kleinzee in the south and Alexander Bay in the north (Figure 1). It is contained within the boundaries of the predefined diamond concession areas 2c, 3c, 4c and 5c and covers an area of 8816.17 km².

A decision has been taken by DBCM to abandon the mining right. As part of the process it is necessary to prepare a Final Closure Plan Environmental Risk Report in terms of Regulations 60 and 62 of GN R 527 Mineral and Resources Petroleum Development Regulations of the Mineral and Petroleum Resources Development Act (28/2002). This BID forms part of the stakeholder engagement required as part of the Closure Plan to be submitted to the Department of Mineral Resources with the Closure Application.

Figure 1: Location and coordinates of the MPT 25/2011 (ML3) Mining Right held by De Beers




HISTORY OF OPERATIONS IN MPT 25/2011

De Beers Marine (DBM) is a South African-registered company providing marine prospecting and mining services to various clients, including DBCM. Since 1983 DBM has been prospecting in sea concessions 2-5c, 7-10c and 12c, under contract to the licence holder DBCM. In January 2003, DBCM was successful in its application for a mining authorization for portions of sea areas 2c, 3c, 4c and 5c, previously known as ML3/2003 (ML3), but now referenced by the Department of Mineral Resources as MPT 25/2011. A vessel platform was purchased in 2005 and converted into a mining vessel, the *mv Peace in Africa*, in 2006/7, before going into full production in May 2007.

Mining was conducted using a seabed crawler which was lowered to the seabed and controlled remotely from the surface support vessel. The vehicle was fitted with highly accurate acoustic seabed navigation and imaging systems, and mined by systematically advancing along a 'lane'. Unconsolidated surface sediment was pumped to the vessel for processing onto multi-decked screens to separate the boulders and sandy silt from the size fraction of interest. Positioning of the vessel and crawler was designed to prevent discarded tailings from settling into the mined areas as the crawler moved along a track. Crawlers are capable of achieving more thorough coverage of the target area, thus avoiding the need for re-mining. The mining vessel employed dynamic mooring, using multi-anchor systems to allowing the vessel to locate itself precisely over a mining area.

Mining of the licence area was undertaken by the *mv Peace in Africa* between May 2007 and January 2010. During that period a total area of 4.8 km² within the Mining Licence was depleted from areas located at water depths of 100-160 m.






Figure 2: mv Peace in Africa mining vessel, representation of horizontal mining and illustration of the seabed crawler.

HISTORY OF LEGAL COMPLIANCE AND ENVIRONMENTAL PERFORMANCE

Operations in the mining licence area were subject to international, national and local environmental legal requirements. Measures to ensure compliance with these requirements were implemented through DBM's environmental legal register. The legal register, as well as compliance with the relevant legislation, was regularly audited as part of DBM's certification to the ISO14001 standard.
