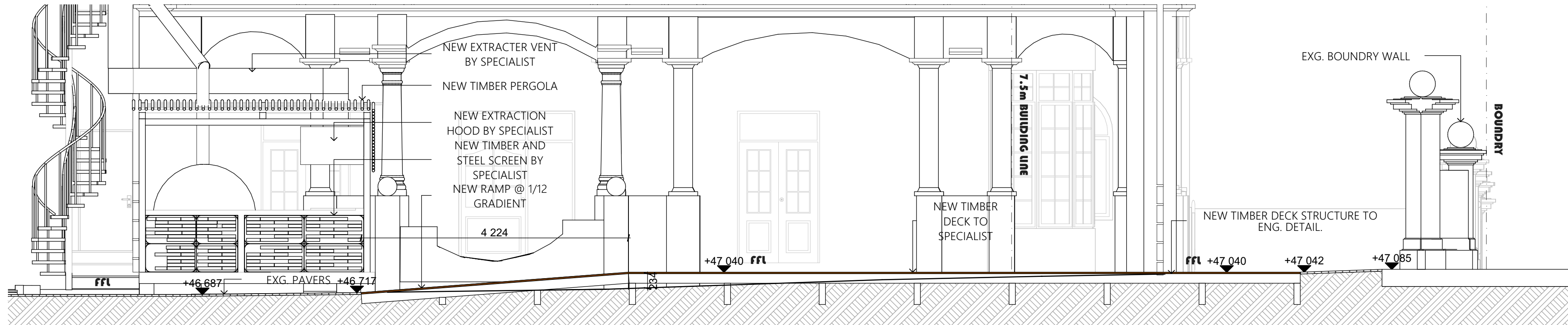
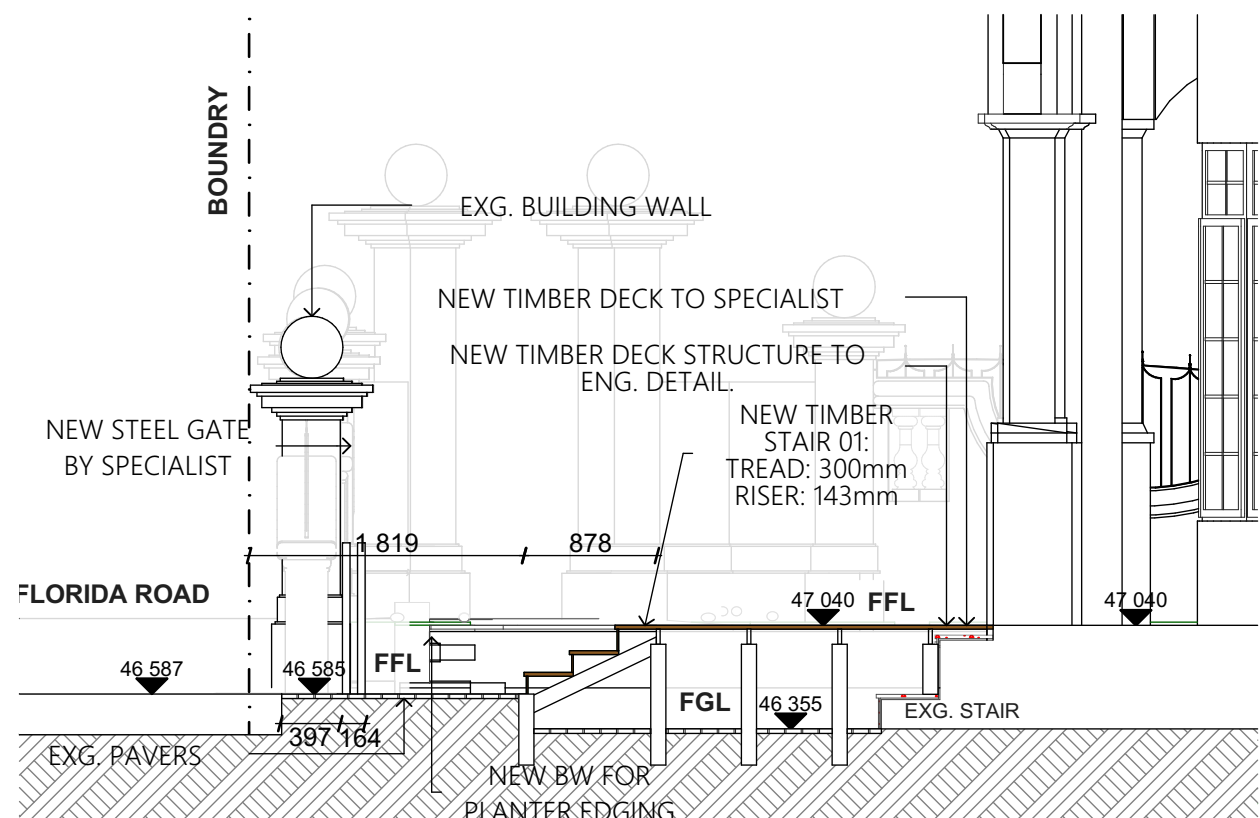


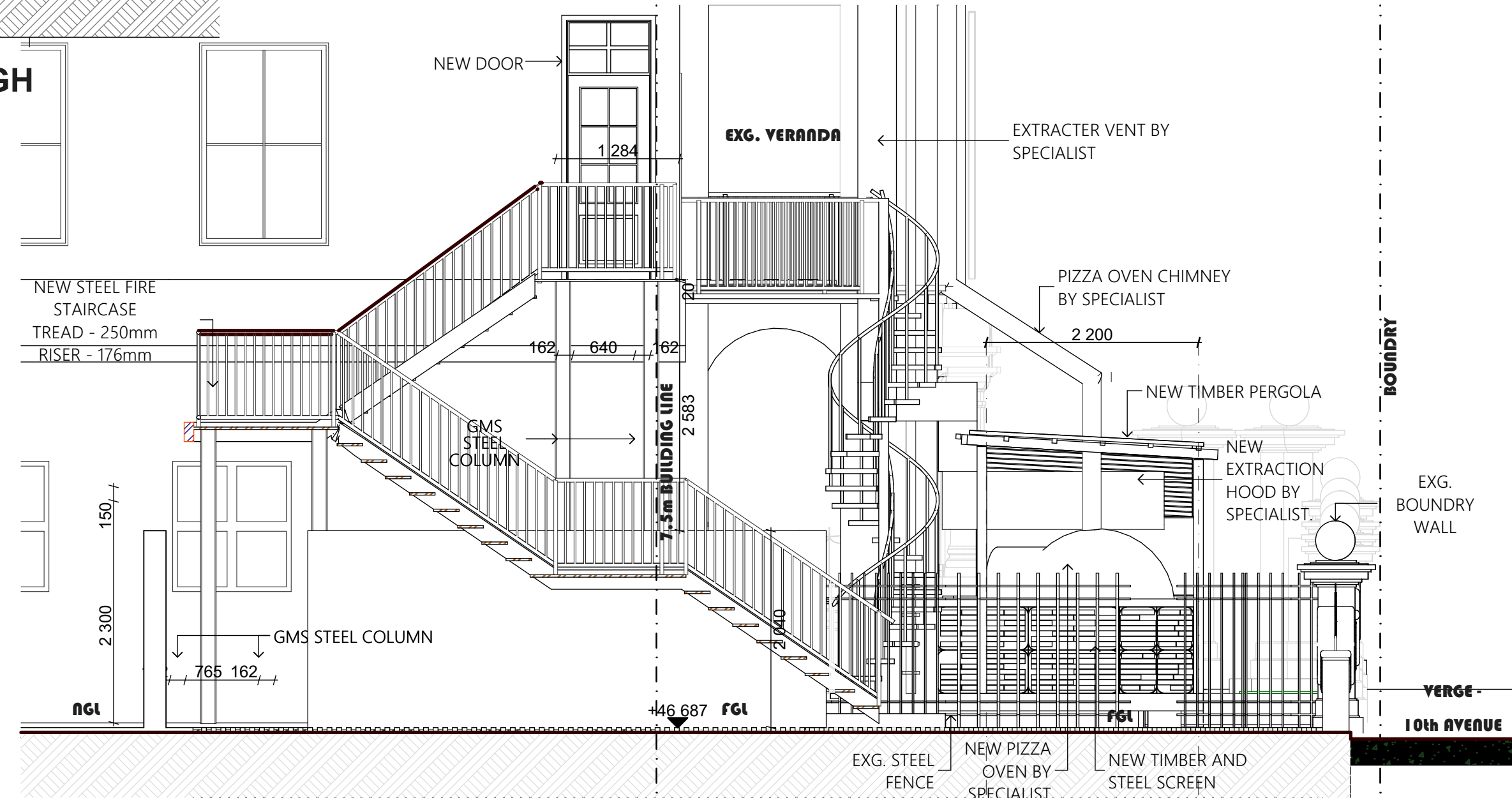
SECTION D1 - D1 : SECTION THROUGH DECK AND STAIRCASE 02

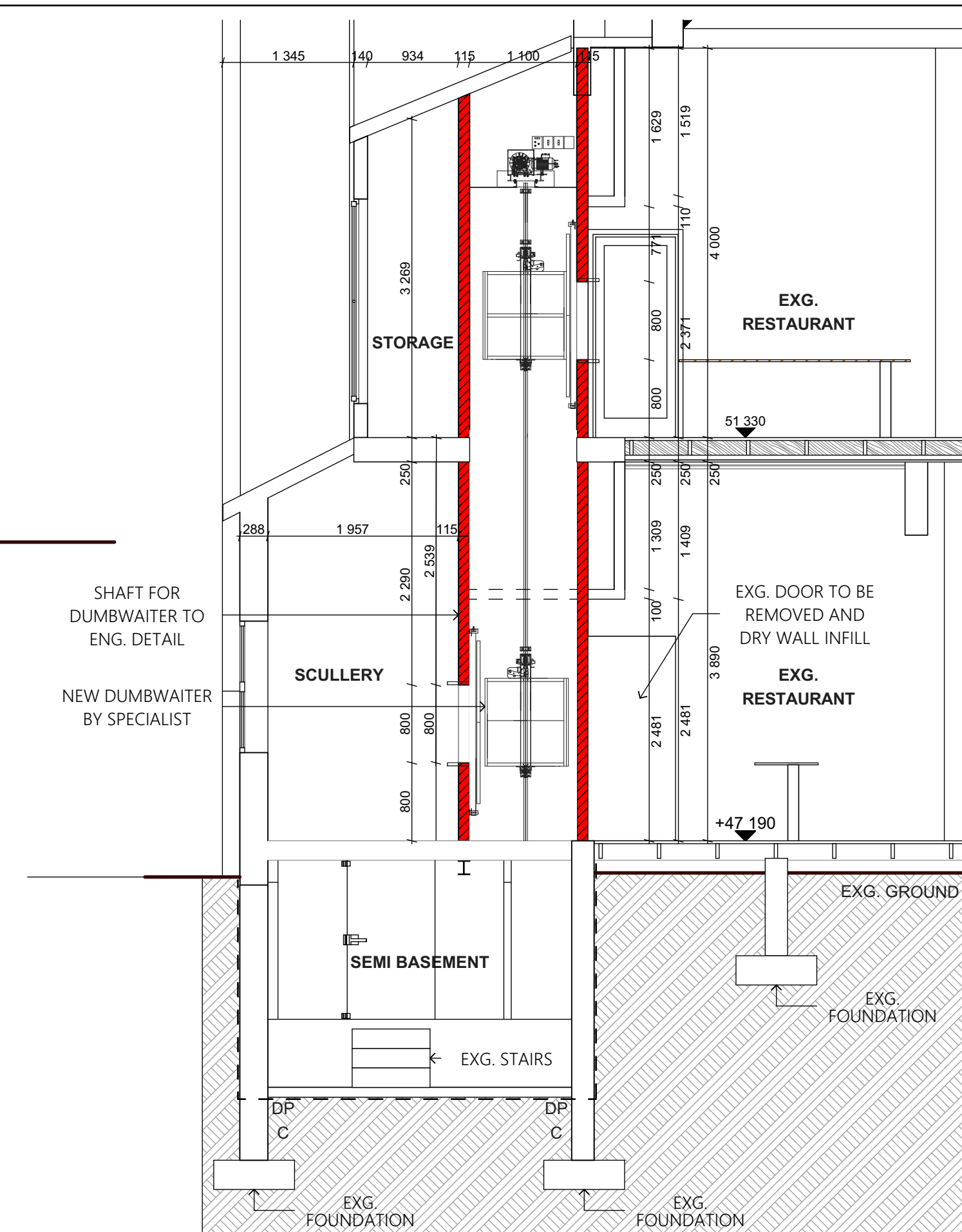
SECTION D3 - D3 : SECTION THROUGH DECK AND RAMP

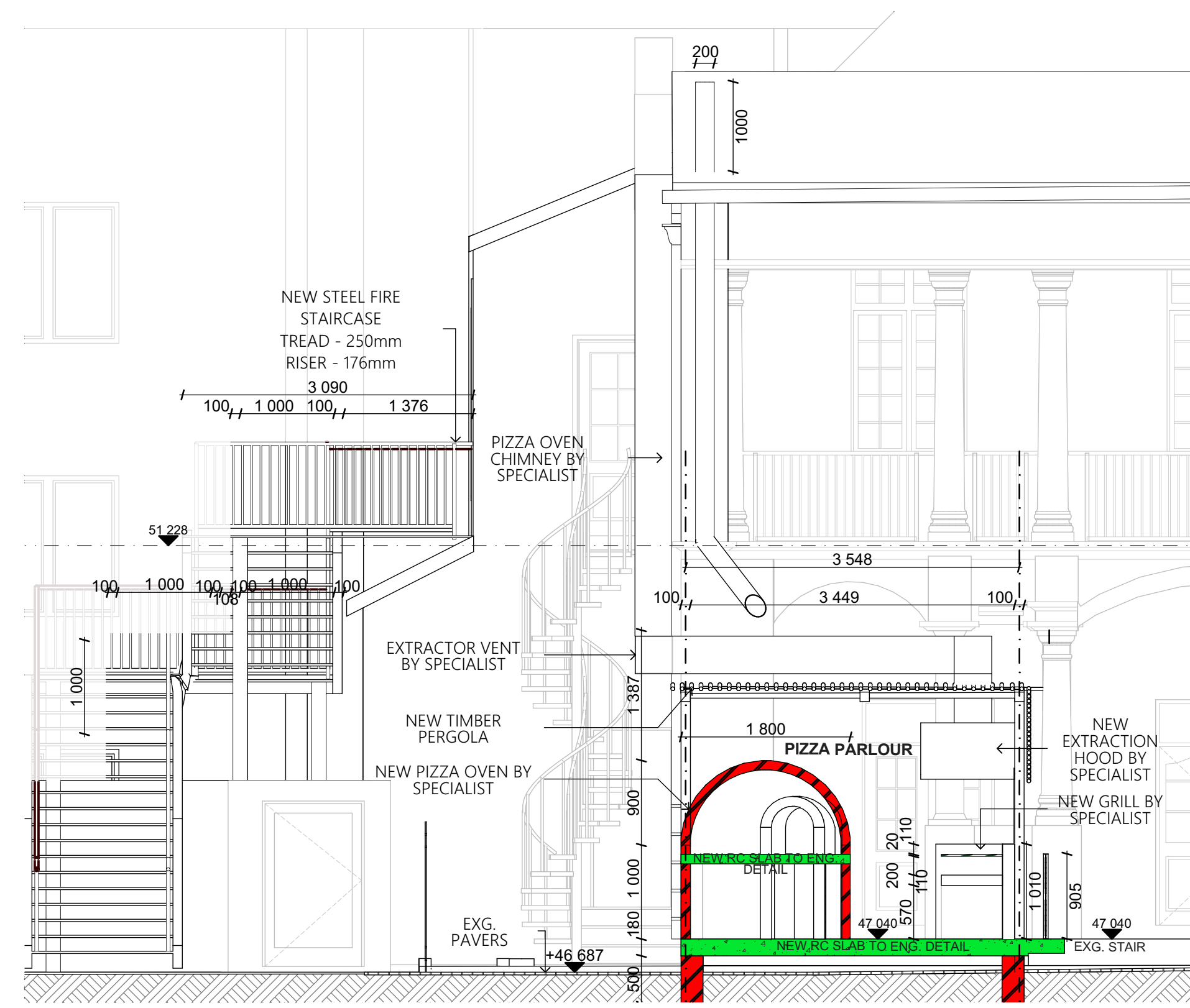
SECTION D1-D1 : SECTION THROUGH STAIRCASE 01
