- A new 132kV power line between the on-site substation and the Eskom grid connection point.
- Battery storage with up to 6 hours of storage capacity.

The power line corridor will be situated within the Remaining Extent of the Farm Rosendal 673, Portion 4 and the Remaining Extent of Portion 3 of the Farm Waterloo 730. Two grid connection alternatives are being considered:

The North West Department of Rural, Environment and Agricultural Development (READ) is the Commenting Authority for this application.

The procedure to be followed in applying for environmental authorisation for a large-scale project in a REDZ was formally gazetted on 16 February 2018 (in GN113 and GN114). As the project is located within one of the eight REDZ areas, the Moeding Solar PV Facility is now subject to a Basic Assessment and not a full EIA process, as well as a shortened timeframe of 57 days for the processing of an Application for Environmental Authorisation by DEA.

Savannah Environmental (Pty) Ltd has been appointed as the independent Environmental Assessment Practitioner (EAP), responsible for undertaking the impact assessment process (Basic Assessment) to identify and assess all potential environmental impacts associated with the project for the area as identified.
