AVAILABILITY OF FINAL BASIC ASSESSMENT REPORTS FOR REVIEW AND COMMENT

Our correspondence dated 14 December 2021, in which you were notified of the outcomes of the investigation into the complaints lodged against the respective Basic Assessment processes for the Wind Garden Wind Farm (DFFE Ref. No.: 14/12/16/3/3/1/2314) and Fronteer Wind Farm (DFFE Ref. No.: 14/12/16/3/3/1/2315) and associated infrastructure, Eastern Cape Province, refers. In their decision on the complaint, the Department of Forestry, Fisheries and the Environment (DFFE) has directed the Environmental Assessment Practitioner (EAP) to conduct a 30-day Public Participation Process to consult on any outstanding issues identified in the processes for these projects after which the Department will continue with decision making. As agreed with the Department, this additional public participation period is to be afforded to registered interested and affected parties (I&APs), and the purpose thereof is to conclude any outstanding issues only. This, third (3rd) release of the respective Basic Assessment Reports is not to invite new I&APs to register or to invite new comments.

An addendum to the approved Public Participation Plan for the cluster of renewable energy projects proposed has been compiled and submitted to DFFE to provide details of the public participation activities to be undertaken to address this requirement. The addendum was approved by the DFFE on 10 January 2022 and is attached hereto for your information.

For ease of reference, all outstanding issues which will relate to the 30-day Public Participation period, as part of this Addendum have been summarised below:

The Public Participation Plan for the Development of a cluster of Renewable Energy Facilities between Somerset East and Grahamstown, Eastern Cape Province, approved by the Department of Forestry, Fisheries and the Environment (DFFE) on 02 November 2020 has reference.
