NOTICE OF AMENDED ENVIRONMENTAL AUTHORISATION ISSUED

ABO Wind Lichtenburg 2 PV (Pty) Ltd obtained Environmental Authorisation (EA) from the Department of Environment, Forestry and Fisheries¹ (DEFF) on 02 July 2019 for Lichtenburg 2, a 100MW Solar Photovoltaic (PV) Facility and Associated Infrastructure near Lichtenburg within the Ditsobotla Local Municipality, Ngaka Modiri Molema District Municipality, Northern West Province

The applicant hereby notifies all registered interested and affected parties, as instructed by the decision issued by the Department on 25 March 2021, and in terms of Regulation 4(2) of the Environmental Impact Assessment Regulations, 2014, as amended, that the Department has decided to amend the EA, dated 02 July 2019.
