




### MAP OF RELATIVE AGRICULTURE THEME SENSITIVITY




# MAP OF RELATIVE AQUATIC BIODIVERSITY THEME SENSITIVITY




# MAP OF RELATIVE AVIAN THEME SENSITIVITY


# MAP OF RELATIVE CIVIL AVIATION (SOLAR PV) THEME SENSITIVITY


# MAP OF RELATIVE DEFENCE THEME SENSITIVITY


# MAP OF RELATIVE LANDSCAPE (SOLAR) THEME SENSITIVITY


# MAP OF RELATIVE PALEONTOLOGY THEME SENSITIVITY




# MAP OF RELATIVE RFI THEME SENSITIVITY
