

'Party kón, maar wóú nie keer nie'

As die parlement nie sy toesig behoorlik vervul nie, sal Suid-Afrika volgens hoofregter Raymond Zondo ook nie in die toekoms staatskaping kan keer nie.

Adv. Lawson Naidoo van die Raad vir die Bevordering van die Suid-Afrikaanse Grondwet (Casac) het met Zondo saamgestem en met verwysing na die parlement gesê daar is 'n groot gebrek aan toesig en verantwoordbaarheid.

Zondo, wat voorsitter van die kommissie van ondersoek na staatskaping was, het gister op News24 se On the Record-konferensie in Sandton gesê een van die belangrikste vrae oor staatskaping is waarom die parlement niks gedoen het om dit te keer nie.

Zondo kap ANC wat 'homsel' beskerm

"Hulle het die mag gehad om dit te doen, maar die meerderheidsparty (ANC) wou dit nie doen nie. Die opposisiepartye het verskeie kere gevra vir ondersoek na die Guptas se invloed op die president (Jacob Zuma), maar die meerderheidsparty wou dit nie toelaat nie."

Zondo wou weet of parlementslede blind was vir die getuienis oor staatskaping wat destyds die media en die openbare domein oorheers het.

Mosies van wantroue in Zuma was volgens Zondo 'n ander manier om staatskaping hok te slaan. Ook daaraan wou die ANC nie byt nie.

"Het hulle dit gedoen om die president en die party te beskerm? Ek sou dink daar is kwessies waar die parlement sou sê: Hier kom die belange van die mense ter sprake."

Zondo het opgemerk dat pres. Cyril Ramaphosa en Gwede Mantashe, nasionale voorsitter van die ANC, voor sy kommissie getuig het dat ANC-lede nie 'n mosie van wantroue in hul president mag ondersteun nie.

"Beteken dit dan dat daar 'n risiko is dat staatskaping weer kan plaasvind en dat die parlement niks daaraan sal wil doen nie?"

Ronald Lamola, minister van justisie en korrektiewe dienste, is op 'n paneelbespreking gevra of die ANC anders sal optree as staatskaping weer in die toekoms voorkom.

"Ja," was sy antwoord. Hy het ook gewys op stappe wat die ANC gedoen het teen lede wat in die hof moet teregstaan op aanklagte van korrupsie.

Zondo het na die "verskriklike tyd van staatskaping" verwys en gesê die miljardende wat verlore gegaan het, kon gebruik gewees het vir die bou van huise, klinieke, skole, paaie en die instandhouding van infrastruktuur.

Volgens Zondo is daar 'n regsraamwerk vir die bekamping van korrupsie en staatskaping.

Syfers verskil, maar nuwe vlag kan dalk einde Oktober kom

Te midde van vrese dat 'n nuwe vlag van Covid-19 die land binne die volgende twee maande kan tref, het die Wes-Kaap die afgelope week 'n afname van 35% in gevalle gehad.

Dit verskil egter radikaal van die situasie landwyd, waar daar 'n 600%-toename in SARS-CoV-2-infeksies was, volgens statistieke van die departement van gesondheid.

Dié nasionale syfers moet egter dalk voorlopig met 'n knippie sout geneem word, omdat die Nasionale Instituut vir Oordraagbare Siektes se jongste verslag aandui daar was in die week tot 27 Augustus 'n 10,9%-afname vergeleke met die vorige week.

Covid-19-statistieke word fyn dopgehou nadat kenners vandeeweek gewaarsku het dat Suid-Afrika waarskynlik 'n sesde vlag van infeksies sal beleef en dat dit dalk al vandeemaand sal wees.

Intussen het prof. Shabir Madhi, dekaan van die fakulteit gesondheidswetenskappe van die Universiteit van die Witwatersrand, gesê hy skat die volgende vlag sal die land eers later tref, dalk teen die einde van Oktober.

Hy stem saam met ander kenners dat daar nie te veel peil getrek kan word op syfers oor nuwe

gevalle nie, omdat mense hulle nie meer so gereedlik laat toets nie.

Volgens die departement van gesondheid is daar in die week van 25 tot 31 Augustus 24 sterftes aangemeld teenoor 18 die vorige week. Dit is moeilik om op grond hiervan enige gevolgtrekkings oor tendense te maak.

Madhi verwag ook dat 'n sesde vlag minder erg sal wees, nes die vyfde vlag, wat deur subvariante van Omikron aangedryf is. Hy skat dat sowat 90% van mense in die land al immuuniteit het, of dit nou danksy inenting of danksy natuurlike infeksie is.

Hoewel dit alombekend is dat entstowwe geen waarborg teen infeksie bied nie, kan mense, veral diegene wat 'n hoë risiko het om weens Covid-19 ernstig siek te word, se immuuniteit volgens Madhi deur inenting versterk word.

■ In die Wes-Kaap was daar vir die tydperk van 24 tot 31 Augustus 'n afname in nuwe gevalle, hospitalisasie en sterftes weens Covid-19.

Op 24 Augustus was daar 549 aktiewe gevalle en teen 31 Augustus het dit tot 341 afgeneem. 'n Afname van 208 (35%) gevalle. Hospitalisasie het ook in dié tydperk met 43% afgeneem van 46 pasiënte op 24 Augustus tot 26 pasiënte op 31 Augustus met net een sterfte weens Covid-19.

Enyobeni: Families kry nuus oor oorsaak

Die families van die 21 jong mense wat by die Enyobeni-taverne in Oos-Londen dood is, is gister ingelig oor die oorsaak van hul kinders se dood.

Yonela Dekeda, woordvoerder van die Oos-Kaapse departement van gesondheid, wou nie uitwee oor wat in die verslae staan nie en wou nie reageer op beweringe dat die families ingelig is dat hul kinders doodgetrap of gedruk is nie.

Sy het wel gesê dit was "moeilik om die doodsoorsaak te bepaal".

Dekeda wou ook nie reageer op beweringe dat metanol nie die oorsaak van die jong mense se dood was nie. In Julie is daar op 'n media-konferensie bekend gemaak bloedmonsters van al 21 oorledenes het metanol bevat, maar dat die vlak daarvan in hul bloedstroom nog bepaal moes word om vas te stel of dit doodlik was.

"Uit respek vir die oorledenes en hul families maak ons nie die bevindinge bekend nie," sê Dekeda. "Dit is nie die staat se kinders wat dood is nie, dit is die families

s'n; dus is dit privaat gedoen."

Die families van drie van die oorledenes kon nie gister bereik word nie, maar al die ander families is individueel oor die oorsaak van hul familielid se dood ingelig.

"Ons kon nie die oorsaak van dood in groepverband bekend maak nie, want ons het 'n verantwoordelikheid om die oorledenes se waardigheid en privaatheid te beskerm."

Oor klagtes van families dat hulle nie afskrifte van die verslae ontvang het nie, sê Dekeda: "Ons kon dit nie vir hulle gee nie, want dit is vertroulik. Ons het reeds die eerbare ding gedoen om die uitslag aan hulle oor te dra. Ons het hulle ingelig oor watter stappe hulle moet volg om 'n afskrif daarvan te kry. Ons is 'n regering wat omgee. Wat belangrik is, is die ondersoek en die integriteit daarvan. As die saak dalk in die hof beland, sal dit die toets moet deurstaan."

Dekeda sê die verslae gaan nou aan die polisie oorhandig word.

Volksblad se pogings om die familie van die oorledenes te identifiseer is nie suksesvol.
