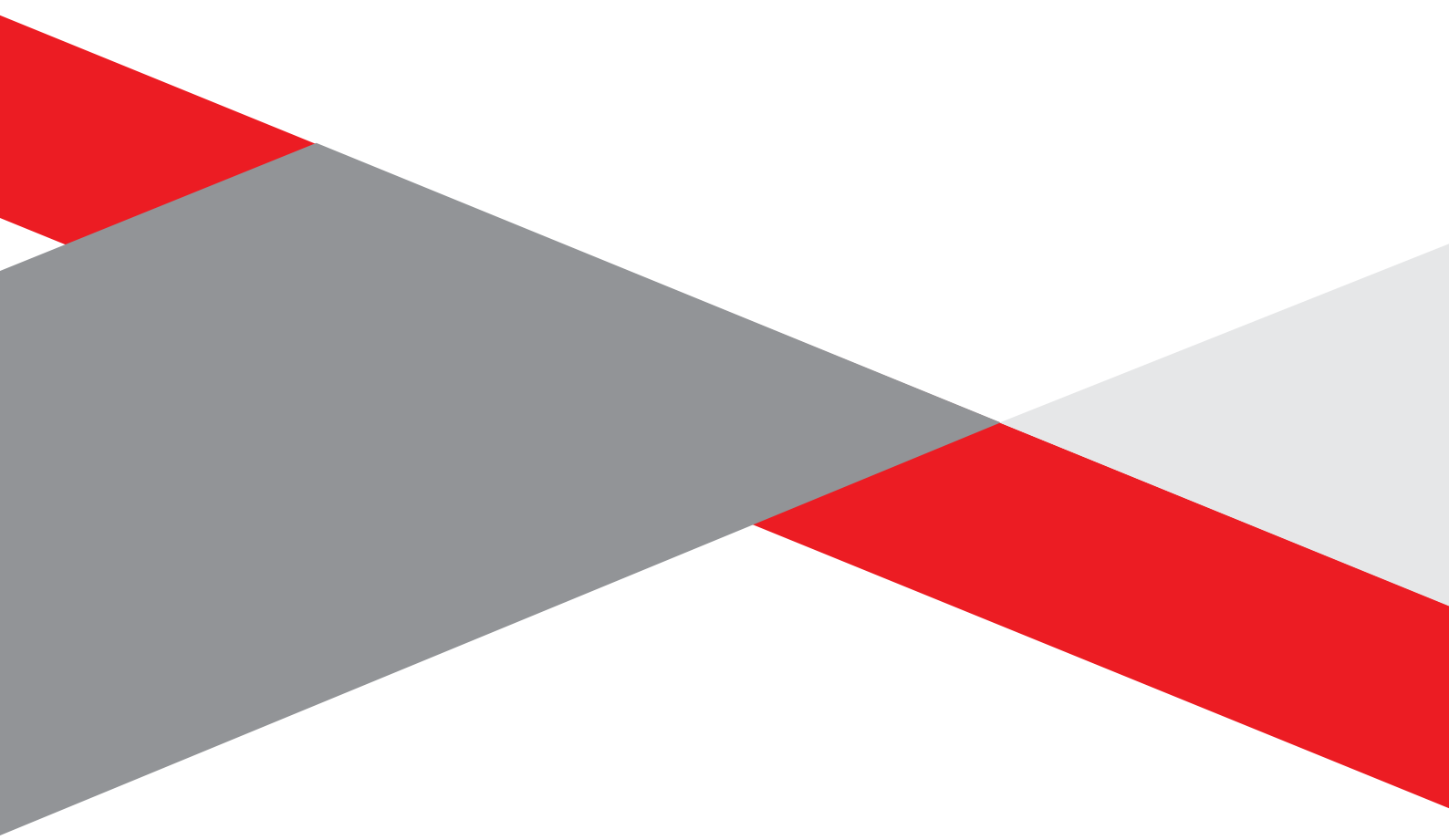

NOTICE OF ENVIRONMENTAL IMPACT ASSESSMENT AND PUBLIC PARTICIPATION PROCESS

PROPOSED DEVELOPMENT OF AN AGRICULTURAL DEVELOPMENT AND ASSOCIATED INFRASTRUCTURE, SOUTHWEST OF LUCKHOFF AND KOFFIEFONTEIN FREE STATE PROVINCE

Proposed Activity: The development of an agricultural development and associated infrastructure on a site located Southwest of Luckhoff and Koffiefontein in the Free State Province. The development will take place on a site of approximately 2690ha in extent across 10 interlinked properties within the Letsemeng Local Municipality of the Xhariep District Municipality. Infrastructure associated with the agricultural development will include the following:

- » Two Underground PVC fiberglass X 1.4m on 5.93km pipeline route;
- » Pipeline network to various center pivot areas
- » Two dams with three alternatives sites (capacity and characteristics not yet confirmed);
- » 1 Pump station covering total surface area of 549m²;
- » A 9ha Solar PV With 4 alternatives and a 5MW overhead power line of 6.9km in length;
- » A Battery Energy Storage System Covering Surface Area pf 0.36ha.

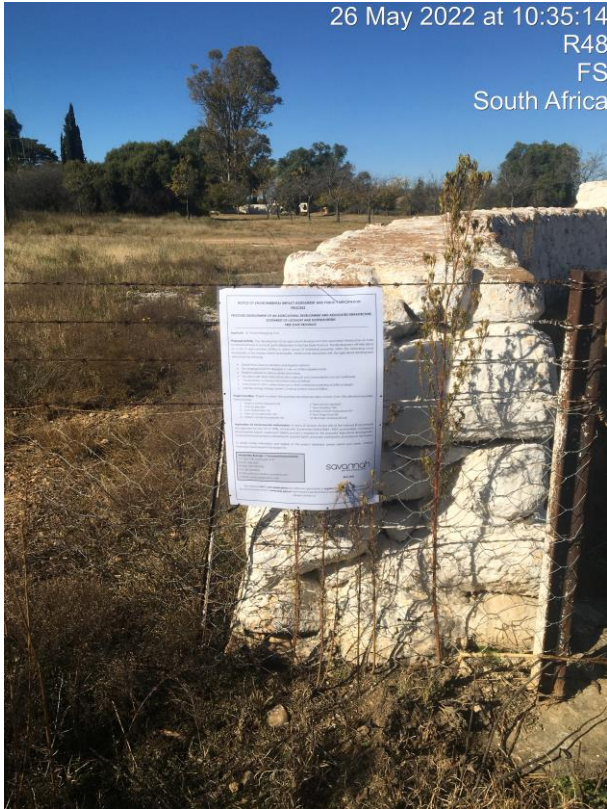
