

The purpose of the Project will be to supply power to a private offtaker via a newly proposed 88kV single circuit overhead power line. The overhead powerline will be approximately 2.5km in length and will be routed across several privately-owned properties from the onsite facility substation to the point of interconnection, north of the N4 Bakwena Highway.

The development of the Solar PV Energy Facility is aimed at diversifying the energy mix for the private offtaker and to reduce their reliance on Eskom supplied power. It is also a conscious effort for the offtaker to contribute to their sustainability targets and reduce their carbon footprint.

A grid connection corridor, which varies in width from 200m to 300m, and is up to 2.5km in length has been identified for assessment. The proposed grid connection infrastructure will be positioned within the confines of the assessed corridor.
