WSP Group Africa (Pty) Ltd has been appointed by Sol Invictus (Pty) Ltd to undertake a Basic Assessment process in terms of the National Environmental Management Act (Act 107 of 1998) for the establishment of a 132kV Overhead Powerline (OHPL) near Aggeneys, Northern Cape Province. The proposed OHPL is approximately 23km in length and will traverse the following properties:

- Portion 5 of Farm 66
- Portion 6 of Farm 66
- Portion 14 of Farm 66
- Portion 5 of Farm 62
- Portion 6 of Farm 62
- Portion 2 of Farm 62
- Portion 1 of Farm 56
- Portion 2 of Farm 56

As part of the stakeholder consultation process we are obliged (by the legislation) to not only notify the relevant landowners in the area but also the occupiers of the farms (i.e. anyone living on, leasing the land or managing it on your behalf) either directly affected by the OHPL or those farms neighbouring the OHPL.

Our records indicate that your farm is directly affected by the OHPL / that your farm is neighbouring the proposed OHPL. **Please could you confirm, in writing, whether there is anybody living on your farm. In the event that there are occupiers / tenants, please could you provide us with their contact details so that we can add them to our stakeholder database.**
