

DETAILED PROJECT DESCRIPTION

LOCALITY

Northam Platinum holds the Mining Rights on the farms Booysendal 43JT: Buttonshope 51JT; Pietersburg 44JT; Uysedoorns 47JT; Kliprivier 73JT; Draaikraal 48JT (portions of which has now been consolidated into Scheeprun 179JT); ; Johannesburg 45JT; Sheeprun 50JT (and the portion of Scheeprun 179JT which was previously part of Scheeprun 50JT) and a portion of the farm Der Brochen 7JT, Hebron 5JT and Hermansdal 3JT.

The Booysendal Project area is located approximately 46km south of Steelpoort. Both the UG2 and Merensky Reef are present on the mine area.

PROPOSED NEW MINING RELATED INFRASTRUCTURE FOR THE PROPOSED BOOYSENDAL PLATINUM MINE

Access Road

The access road will be from the north off the D212 via the existing Mototolo JV operations towards the Booysendal area.

Bulk Water Supply

During the early stages of development, the Booysendal Operation will utilize a 7Ml/day allocation from the Lebalelo Pipeline that was secured along with the project area from Rustenburg Platinum Mines Ltd. The pipeline route will still be determined.

Power

Electrical power for the initial phase of construction will be supplied under agreement from the current Mototolo Operation / Sub Station. This power will fulfill the needs of the construction phase but additional power is needed for the operational phase. Currently Northam Platinum is in negotiations with ESKOM to supply the necessary power.

Housing

A small allowance has been made for housing during the initial development stage since it is assumed that contractors will carry out the initial work. It is envisaged that houses and or housing subsidies will be available by the time the large mine production build up starts. Taking cognizance of other operations in the area, it is envisaged that management employees would live in Burgersfort and Lydenburg, whilst the majority of the remaining employees would live in either the Sekhukhune or Burgersfort or Roossenekal area.

Main Mining Area

The infrastructure requirements include a tailings dam complex and associated return water dams, security fencing, offices and basic parking areas, change houses, surface stores and central workshops, topsoil stockpile, water and sewage treatment facilities, ore stockpile, waste rock dump, pollution control dams, ventilation fan housing, mine and potable water storage, overland conveyors as applicable, dirty water system and stormwater management and a 120 kilo ton per month plant. All this infrastructure will be located on the farms Booysendal 43Jt and a portion of Der Brochen 7JT for which Northam Platinum holds the surface rights





THE ENVIRONMENTAL AUTHORISATION PROCESS

A number of processes will run parallel during the EMP amendment and consolidation process.

- Mineral & Petroleum Resources Development Act (Act 28 of 2002) in accordance with the requirements of the MPRDA a Mining Right Conversion Application has been lodged with the Department of Minerals and Energy (DME), Witbank Region. Ivuzi has been appointed to co-ordinate, manage and compile the relevant environmental impact and management reports as part of the EMP amendment and consolidation.
- National Environmental Management Act (Act 107 of 1998) In terms of the Environmental Impact Assessment EIA) Regulations (Regulation 386 and 387 dated 21 April 2006) promulgated in terms of Section 24(5) of the National Environmental Act, (Act 107 of 1998), an Environmental Impact Assessment need to be undertaken for listed activities associated with the mining operations.

The EIA process will provide the authorities and I&APs with clear, accurate and understandable information about the expected environmental impacts associated with the mining operation.
