## Introduction

Section 5 (1)(a) of the National Heritage Resources Act 25 of 1999 (NHRA) states that "Heritage resources have lasting value in their own right and provide evidence of the origins of the South African society and as they are valuable, finite, non-renewable and irreplaceable they must be carefully managed to ensure their survival".

On the 08/10/18, Heritage Protection Unit Art Bank and Iziko Museum and Mr Sipho Mndada conducted an inspection at the Freedom Park and National Heritage Monument at the Fountain were the Struggle Icons Statues are displayed. The National Heritage Monument is a group of copper statues representing anti-apartheid activists, Zulu chiefs and missionaries. The monument is meant to reflect the struggle for liberation going back into the 1600s. It is in Groen Kloof Nature Reserve.

### Purpose of the site visit

The site visit was conducted as part of monitoring national art work which is heritage related in Gauteng Province. The Art Work and Iziko Museum wanted to establish if the site is national declared site. This was done to ensure that the authority responsible follows section 5 of the NHRA which states that "Heritage Resources contribute significantly to research, education, tourism and they must be developed and presented for these purposes in a way that ensures dignity and respect for cultural values."
