We wish to consult with the land owner and other affected parties in respect of the application this Company has made for a prospecting right over the aforementioned property. This communication is the start of the consultation process as required by law, which will continue throughout the application process and for the duration of any prospecting right, should such be granted to us. On 22 October 2014, De Beers Consolidated Mines Proprietary Limited (“De Beers”) lodged an application for a prospecting right for diamonds, in terms of Section 16(2) of the Mineral and Petroleum Resources Development Act, No. 28 of 2002 (“the Act”), in respect of the aforementioned property. To date De Beers has not received acceptance of the application from the Department Mineral Resources.

Application has also been made for permission in terms of Section 20(2) of the Act to remove and dispose of such bulk samples of any potentially diamond -bearing minerals found by De Beers in the course of prospecting operations conducted pursuant on any prospecting right issued in favour of De Beers.
