

1. INTRODUCTION

1.1 The building was proclaimed a national monument in accordance with government gazettenumber 474 of 1960-04-08, amended nr 560 of 1960-04-22.

1.2 After submission of plans for a new road near the building, the National Monuments Council decided on 1961-09-19 "om die Stadsraad mee te deel dat die Kommissie geen beswaar het teen die plan vir 'n pad wat onder die gebou deur sal loop soos aan lede voorgele..."

1.3 No detail plans were submitted from 1961 - 1990.

1.4 The relocation of the building is totally unacceptable.

2. DISCUSSIONS ON PROPOSED TUNNEL AND TERMS OF AGREEMENTS

2.1 The consultants of the City Council of Pretoria, Van Niekerk, Kleyn and Edwards, approached the Transvaal Plans Committee for the first time during May 1990.

2.2 The Committee was asked to approve plans for the tunnel, which would go beyond the south wing of the building and would require the demolition of various internal sections so that the drilling equipment could be brought inside the building.

2.3 The Committee was totally opposed to the tunnel, which would endanger the building through differential settlement, and which would isolate it on an island of concrete or a tarmac slab.

2.4 It would also involve major work with heavy equipment causing internal and external damage.

2.5 After various discussions, the Plans Committee asked an interview with the City Council of Pretoria's Chief Engineer, which was held on 1990-07-26. Another meeting with representatives was held on 1990-08-13.

2.6 The City Engineer assured the Committee there was no possible alternative to the tunnel, that the estimated costs of the road was R6 million, that Pretoria required this 8 lane road and that his Council would meet every requirement the NMC made, including:

2.6.1 the City Council's written guarantee that the damage to the

2.6.2 that the City Council provide the NMC with a written guarantee that the City Council would be responsible for the restoration of the building;

2.6.3 that the City Council would set an amount of money aside, in a Trust Fund to provide for restoration work (this also to be in writing);

2.6.4 that the City Council employ an conservation architect of the NMC's choise to monitor the building during construction and to supervise restoration work;

2.6.5 other controls as set out in our letter dated 1990-10-01.

2.7 At the meeting held on 1990-08-13 all the points were confirmed.

2.8 As soon as they had our written agreement in principle and subject to the condisions, the consultants and City Council started to change the conditions.

2.9 The City Council announced that the consultant had to appoint the architect.

2.10 The consultant then reported that the City Council was willing to repair the building but not to restore it.

2.11 The City Council's Chief Engineer was notified by fax that this was a breach of agreement and that permission for the tunnel depended on the agreements being honoured by his Council.

2.12 The Consultant is employing the architect at risk in terms of an amendment of the Plans Committee (see letter 1990-10-26).

2.13 The first correspondence from the City Council was received by fax on 1990-11-16.

3. REGIONAL COMMITTEE

3.1 Abovementioned development was discussed by members of the Transvaal Regional Committee before referring it to the Executive Committee.



Your letter dated 14th November received by fax on 16th November refers.

It is important to clarify this difference of understanding regarding restoration. The point made at our initial meeting was that if you were simply to repair a section damaged during construction it would then differ in paint colour and appear patchy. The whole wall would obviously have to be repainted. It was agreed that the research would be undertaken so that the repairs would not simply reinstate the existing, but would be correct historically as far as is practicable.

Mr Holm has already indicated two examples.

1) The correct paint colours for walls and dadoes. These would then be used throughout, not simply in the specific sections which are damaged.

Since during the construction dust and exhaust fumes are likely to affect the entire building, it will be necessary for it to be repainted throughout.

2) The original photographs show down-pipes which have subsequently been relocated. These could be used to conceal the expansion joints which both the architects and engineers believed necessary.

However, the building was designed symmetrically so that reinstating the down-pipes on one wing only would actually

The Plans Committee believed the following should be the accepted restoration principles:

- Where alteration / demolition / damage occurs the repair should be correct to the original specifications where possible or practicable in view of the change in use.
- These restorations should be applied throughout the building, not confined to one wing only.

Points one and two are considered an essential requirement.

 There may be other original details which have been removed over the years, and which are not affected by the subway construction.

Costs of such restoration will be obtained and submitted for consideration by your Council. (For instance the building originally had a stoep.) It is hoped the Pretoria City Council would be willing to undertake this sort of work so that the building will have benefited to some extent from the subway.

Your letter will be submitted to the NMC Executive Committee Meeting in December.

1. INTRODUCTION

1.1 The building was proclaimed a national monument in accordance with government gazettenumber 474 of 1960-04-08, amended nr 560 of 1960-04-22.

1.2 After submission of plans for a new road near the building, the National Monuments Council decided on 1961-09-19 "om die Stadsraad mee te deel dat die Kommissie geen beswaar het teen die plan vir 'n pad wat onder die gebou deur sal loop soos aan lede voorgele..."

1.3 No detail plans were submitted from 1961 - 1990.

1.4 The relocation of the building is totally unacceptable.

2. DISCUSSIONS ON PROPOSED TUNNEL AND TERMS OF AGREEMENTS

2.1 The consultants of the City Council of Pretoria, Van Niekerk, Kleyn and Edwards, approached the Transvaal Plans Committee for the first time during May 1990.

2.2 The Committee was asked to approve plans for the tunnel, which would go beyond the south wing of the building and would require the demolition of various internal sections so that the drilling equipment could be brought inside the building.

2.3 The Committee was totally opposed to the tunnel, which would endanger the building through differential settlement, and which would isolate it on an island of concrete or a tarmac slab.

2.4 It would also involve major work with heavy equipment causing internal and external damage.

2.5 After various discussions, the Plans Committee asked an interview with the City Council of Pretoria's Chief Engineer, which was held on 1990-07-26. Another meeting with representatives was held on 1990-08-13.

2.6 The City Engineer assured the Committee there was no possible alternative to the tunnel, that the estimated costs of the road was R6 million, that Pretoria required this 8 lane road and that his Council would meet every requirement the NMC made, including:

2.6.1 the City Council's written guarantee that the damage to the

building would be kept to the minimum;

2.6.2 that the City Council provide the NMC with a written guarantee that the City Council would be responsible for the restoration of the building;

2.6.3 that the City Council would set an amount of money aside, in a Trust Fund to provide for restoration work (this also to be in writing);

2.6.4 that the City Council employ an conservation architect of the NMC's choise to monitor the building during construction and to supervise restoration work;

2.6.5 other controls as set out in our letter dated 1990-10-01.

2.7 At the meeting held on 1990-08-13 all the points were confirmed.

2.8 As soon as they had our written agreement in principle and subject to the condisions, the consultants and City Council started to change the conditions.

2.9 The City Council announced that the consultant had to appoint the architect.

2.10 The consultant then reported that the City Council was willing to repair the building but not to restore it.

2.11 The City Council's Chief Engineer was notified by fax that this was a breach of agreement and that permission for the tunnel depended on the agreements being honoured by his Council.

2.12 The Consultant is employing the architect at risk in terms of an amendment of the Plans Committee (see letter 1990-10-26).

2.13 The first correspondence from the City Council was received by fax on 1990-11-16.





THE DOUBLING OF SKINNER STREET, STAATS MODEL SCHOOL

My discussion with Mrs van der Merwe on 2nd July 1991 refers.

As you are aware the National Monuments Council has in principle given permission to the Council to construct a tunnel underneath the Staats Model School, subject to certain conditions.

During the detail design stage of this project, it became evident that the costs involved in providing the tunnel would be more than three times higher than originaly estimated, mainly due to unforeseen circumstances. Consequently other alternatives had to be investigated.

Of the alternatives investigated, only the following two alternatives required further attention:

1. Re-align Skinner Street between the Staats Model School and Vista University. (See alternative 2 on attached plans).

This alternative was also investigated at an earlier stage, but because of the limited space available pedestrians could not be accommodated satisfactorily.

After further investigation the possibility to accomodate pedestrians underneath the building of Vista University, between the pillars, underneath the first floor, was discussed with the Rector and his committee, who, in principle agreed to consider this proposal, subject to further information.

As can be seen on the plans, it will also be necessary to accommodate pedestrians on the property of the Staats Model School.

2. Re-alignment of Skinner Street and demolish a part of the building of Vista University and possibly the Church on the south-western corner of van der Walt- and Skinner Street. (See Alternative 1 on attached plans.)

For this alternative the northern portion of the building of Vista University will have to be demolished. In this instance the personnel of the University will have to be resettled as the remaining portion of the building would not suit their requirements. This factor will have a serious effect on the completion time of the project.

It is also possible that the abovementioned church may have to be demolished for this alternative.

A preliminary cost estimate has shown that Alternative 1 is in the order of 30% more expensive than Alternative 2, that is about R9 million more expensive.

Should alternative 2 therefore not be acceptable it could have a serious cost implication for the Council.

In view of the abovementioned it would be appreciated if your Committee would consider alternative 2 and supply this Department with your comments/recommendations.

Your letter dated 19 July 1991 refers.

With regard to the conditions of approval, as set out in you letter, this Department would like to provide the following information:

Paragraph 5.10.1.1 This condition is acceptable.

Paragraph 5.10.1.2 This Department has appointed consultants to carry cut a noise impact study. As soon as the study is completed the matter of accustic treatment will be finalised.

Paragraph 5.10.1.3 Width of the median. Attached is a drawing of the median (cross section). As can be seen the raised portion of the median is only 1,3m wide which leaves very limited space for pedestrians who might seek refuge on the median.

Furthermore, it is a requirement that a traffic signal be erected on the median. It is not possible to erect a traffic signal on a median narrower than 1,3 m.

The width of the median provided is already a minimum standard and can therefore not be reduced.


I trust that this will be acceptable to your Council.

THE entire new R35-million doubled Skinner Street might be made to curve around the south side of the historic Staats Model School.

This was indicated by Dr Chris Swart, management committee member in charge of the city engineer's department, who said the cost of more than R20-million for a cubway underneath the Staats Model School, which may not be touched, was too expensive.

The street passing south of the historic monument would mean the city council will have to expropriate and demolish more buildings, including the University of South Africa's Samuel Pauw Building.

Mr Albrecht Holm, deputy chairman of the Pretoria branch of the Simon van der Stel Foundation, has meanwhile reacted to remarks by Dr Swart, describing them as "typically" not touching the merits of the matter.

Dr Swart had said road construction was "not the foundation's terrain". While the council was "very sensitive" about not damaging historic buildings, it was responsible for development.

"We must also look forward and not backward all the time. It is our task to make the city accessible," he said.

Mr Holm said he could confirm that roads were not the foundation's calling, "but conservation is".

"We see progress not as demolishing buildings, but as utilising the old.

"The destruction caused with the freeway is not limited to the couple of buildings being demolished, but goes much further in that the city is cut into pieces and polluted with noise, exhaust fumes and dangers," he said.
