NOTIFICATION OF AVAILABILITY OF A DRAFT BASIC ASSESSMENT REPORT FOR PUBLIC REVIEW AND COMMENT

RE: BASIC ASSESSMENT (BA) PROCESS FOR THE PROPOSED CASTEEL DAM SAFETY REHABILITATION PROJECT, BUSHBUCKRIDGE LOCAL MUNICIPALITY, EHLANZENI DISTRICT, MPUMALANGA PROVINCE. DFFE Ref. Pending

Our previous correspondence of 15 October 2022 has reference. Kindly note the Draft Basic Assessment Report (BAR) for the above-mentioned project is available for review and comment.

As previously informed, the Department of Water and Sanitation (DWS), Directorate: Strategic Infrastructure Asset Management (SIAM) is proposing to conduct scheduled rehabilitation works at Casteel Dam. Casteel Dam is located next to the R40 main road, 15km North of Bushbuckridge enroute to Acornhoek. Naledzi Environmental Consultants (Pty) Ltd is the appointed independent environmental assessment practitioner, responsible to undertake the Basic Assessment (BA) process in support of the application for environmental authorisation for the project.

The application together with a copy of the Draft BAR Report have been submitted to National Department of Forestry, Fisheries and Environment (DFFE) in June 2023 and is currently subject to a 30-day public review and comment period from Friday, 30 June until Monday, 31 July 2023.
