In terms of Section 36 (3) of the National Heritage Resources Act, 1999 (Act No. 25 of 1999) no person may, without a permit issued by the relevant heritage resources authority:

(a) destroy, damage, alter, exhume or remove from its original position or otherwise disturb the grave of a victim of conflict, or any burial ground or part thereof which contains such graves;

(b) destroy, damage, alter, exhume or remove from its original position or otherwise disturb any grave or burial ground older than 60 years which is situated outside a formal cemetery administered by a local authority; or

(c) bring onto or use at a burial ground or grave referred to in paragraph (a) or (b) any excavation equipment, or any equipment which assists in the detection or recovery of metals.

Other application forms are available for archaeological and palaeontological material and sites (302), for shipwrecks (303), for the export or sale of heritage objects including archaeological and palaeontological material, material from shipwrecks and meteorites (304), for the built environment and landscape (307) or the registration of private collections (402).

The burial site is located at Tswika Village near Mulima in Makhado Local Municipality; Limpopo Province. The remains were stabilized in situ while arrangements for rescue are underway (See letter from police).

One Burial site was accidentally disturbed by Soekmekaar-Singopowerlineconstruction work at Tswika Village. Work was suspended at tower 152 and the site was barricaded in accordance with the relevant heritage legislation and Management plan for the powerline development.

10. Brief description: Figure 1 and 2.View of pole number 152 for SoekmekaarSingo 132kv powerline and burial site that was accidental discovered.

A solitary human burial site was accidentally discovered during excavation for powerline pole installation for Soekmakaar-Singo 132kv powerline at Tswika Village in Makhado Local Municipality in Limpopo. Construction work was suspended following the discovery and the grave was condoned off. Eskom management commissioned Nzumbululo Heritage Solutions (Heritage specialists) in collaboration with Mafu Funeral Home to verify the accidental discovery and to proceed to apply for reburial permits in order to relocate the grave from the direct path of current construction work. This accidental discovery of human burial prompted the necessity of applying section 36(3) of the National Heritage Resources Act 25 of 1999.

The accidental discovery was reported to Tshitale SAPS and the police attended the scene. Public consultations were initiated in an attempt to identify the possible custodians of the affected grave. The NzumbululoHeritage Solutions team and Tshitale SAPS consulted the local headman-Mukosi John Mitse ID No. 3002025771083 who indicated that the site was previously resided by Khosa Families who were moved to Magoro Village during the establishment of the former Gazankulu Homeland in the 1960s. The Khosa families are now scattered all over former Gazankulu Homeland. The Nzumbululo team proceeded to Magoro Village to trace the Khosa Family. The team consulted Mbhazima RennyValoyi (ID no.53 06 25 5556082 cell number 0839593968) who directed us to Mthabini Ndhima (ID No.30 11 02 0127084, phone no. 0824243455). Mthabini Ndhima confirmed that she belongs to the Khosa Families who were moved from the project area but she was not sure about the affected burial site.The team arranged to go to the site with Mthabini and some family members, Hanyani Thomas Ndhima, Lerisa M. Ndhima and Mbhazima RennyValoyi. Mthabini confirmed that indeed the burial belonged *MdungaziKhosa* her brother. She also indicated that they were some burials belonging to the Khosa Family in the vicinity of the site.

After positively identifying the burial site Mthabini indicated that she will take the responsibility to inform the other family members. She also promised to arrange a meeting for the Nzumbululo team and Khosa family to finalize the reburial arrangements.

On the 31st of October 2013, the Khosa Family representatives met to sign consent forms for processing rescue permit application. Khosa family was represented by MthabiniNdhima, ,Risimati John Khosa, Mbhazima J Khosa, Samson Mabose, EngetaniFamanda Khosa, Mbazima R. Valoyi and Hanyani Thomas Ndhima. During the meeting the family members were concerned about the costs for reburial and the fate of other family graves in the vicinity of the project area. We assured them that the reburial costs will be catered for by the developer.

TshitaleSAPS cleared the discovery from any crime in the area. However they indicated that the remains must be reburied as a matter of urgency because they may be tempered with. The developer resolved that the human burial be rescued and be reburied urgently because it is located far away from households are at risk of being tempered with in the absence of any security measures. The grave is adversely affected by the development by virtue of it being on the direct path of ongoing powerline development and it cannot be left in situ. It is based on that decision that this application is being submitted to facilitate the rescue and reburial of the affected human burial. The remains will be re-interred immediately upon receiving the rescue permit from SAHRA.

The costs of this exercise are included in the professional services being provided by Mafu's Funeral Home and Nzumbululo Heritage Solutions (see attached contract). This includes cost of reburial of final reburial of the human remains. Nzumbululo in collaboration with Mafu's Funeral Home has obtained permission for the remains to be re-interred in the local cemetery at Magoro Village. Mafu's Funeral Home is the approved undertaker service provider and will be managed by Nzumbululo Heritage Solutions to conduct the reburial work.

This is an urgent Rescue Permit application given the observation that the burial has already been partially disturbed. It is this partial disturbance that led to the accidentally discovery of the burial within the foot print of Tower 152. Site management and construction workers are concerned that the exposed human burials may cause instability at the construction site given the fact that the local community's cultural practices do not allow human burials to be exposed for any long time without urgent reburials. As such the Eskom Distribution Limpopo Management urgently needs the burial to be relocated without any further incidents. With the necessary arrangements having been agreed upon with the developer and affected family to exhume and relocate the disturbed remains, we request that the SAHRA BG&G Unit process this urgent application to enable the immediate re-interment of the remains.Should there be any other information that the Agency may require in this regard, Nzumbululo Heritage Solutions will be obliged to make the necessary submissions

Nzumbululo Heritage Solutions assisted by Mafu Funerals will conduct the exhumation and reburial. A qualified archaeologist from Nzumbululo Heritage Solutions will manage and supervise the whole exhumation process. He will also undertake and complete the reporting process thereof.

18. Please give details of consultation with communities and individuals who by tradition has an interest inthe grave(s), and of the agreement reached with such communities and individuals (as required by Act 36 and the relevant Regulations Chps IX and XI)(provide documentation and details):

Consultations were conducted at Tswika and Magoro Villages. Communities that are located from the project area were tracked and we obtained leads with regards to the custodians of the grave. The communities confirmed that the area was resided by Khosa families who were moved to Magoro in the 1960s. Headman Mukosi John Mitse provided important information about the affected area. Tshitale SAPS was consulted and they assisted by announcing the discovery and consulted the traditional authorities in the surrounding villages. They also attended the scene to determine if the remains were linked to any murder crime in the area. Eskom management was also consulted to grant permission for the relocation of the exposed burial. The process was deemed sufficient for the urgent relocation and reburial of the eight adversely affected graves - a mitigation measure to rescue the grave from further disturbance from current power line developments. 


