

PERMIT NO 1/64/06 FOR THE DEMOLITION OF BUILDING AT VOORSPOED DIAMOND MINE, KROONSTAD REGION.

We refer to # 1/64/06 issued in April 2006 that was validated for one year for the demolition of a building on the premises of Voorspoed Diamond Mine near Kroonstad. Owing to several economic factors that impacted on the mine at the date of issue, the demolition was not undertaken at the time. Due to renewed high levels of activity around the construction of the mine, and subsequently the commissioning/operational phase, the demolition of the building was aligned to the EMP update in 2010.

1. We would humbly request your committee to review the situation and review the case for a renewal of the permit. (For your attention there is attached to this letter the original report and other documents regarding the condition and history of the building, and the required demolition permit)

2. On a site visit to the building site on the 28th of April 2012 with architectural conservation advisor, Sidney Miller, it was found that the building was still standing and appeared to be in a similar preservation condition as recorded by Dr. De Jongh and Dr. Bakker in 2006, although some structural stress was apparent. At that stage there were communication with Me J Nel of your department then, regarding the re-issue of the permit. Unfortunately there was a breakdown in communication and a solution of the situation was not forthcoming at the time.

3. This present communication is based on the reality that the mine pit is now endangering the building, and that a solution must be found to assist the mine to adhere to the National Heritage Act, as well as to provide it with the means to proceed with its mining operations.

THE DEMOLITION OF OLD BUILDING AT VOORSPOED DIAMOND MINE, KROONSTAD REGION. (REDUNDANT PERMIT NO 1/64/06REFERRS)

Over the past two weeks we have discussed the question of the re-issuing of a demolition permit regarding Voorspoed Mine. I have re-visited the site in December 2012 and have established that the midden in question is relatively small (perhaps three meters by two meters and no higher than 500 mm in the center.) Superficially it contains mainly coarse ash containing rather diminutive shards of glass, porcelain and the oddments of metal wire and such.

As the 2006 demolition permit required the investigation of this midden and the retrieval of cultural material, I hope that we can bypass this requirement because of the following:-

1. It is expected that very little material is in fact present in the midden.

2. It is expected that the retrieved material will not yield material of any great importance for the greater understanding of the function of the building or its occupants.

3. There is then the question of the custodianship of the retrieved material. As it is expected to be of little importance, as well as of low volume, it will be more of a liability than an asset to any institution that provides shelf and administrative space and time for artifacts.

4. Finally there is the security problem regarding excavations on a diamond mine, and the removal of the retrieved material from the mine premises.

I still hope that a visit to the site by an independent investigator such as possibly Cobus Dreyer, or one of the permit board members may negate the need for the proposed excavation.

Personally, I envisage the 'memorizing' of the early history of the mine in a 'poster' format, both at a suitable place at the mine, as well as at De Beers headquarters museum. With this, I suggest the depository of either the original or copies of all relevant maps and documents relating to the sites early history in the National Archives (or other suitable facility), where it will be available to researchers in the future.

Due to the high levels of activities around the construction of the mine and subsequently the Commissioning/ Operational phase; the demolition of the buildings was delayed and aligned to the EMP update in 2010.

We would humbly request your committee to review the situation and re-issue a new demolition permit.

- 1. Included the following for details for your attention:
 - 1.a. A **Phase I** study of the mining area was undertaken by **Dr. Julius Pistorius** which was submitted to your office. For your convenience we submit this again as an addendum to this letter.
 - 1.b. A **Phase II** study of the building to be demolished was undertaken by **Dr. Robert De Jong** which was submitted to your office. For your convenience we submit this again as an addendum to this letter.
 - 1.c. A **Phase III** application for a demolition permit was also undertaken by **Dr. Robert De Jong** and **Dr. K.A. Bakker** which was submitted to your office. For your convenience we submit this again as an addendum to this letter.
- 2. On a site visit to the building on the 28th of April 2010 with architectural conservation advisor, **Sidney Miller** we found that the building is still standing and appears to be in the same preservation condition as documented by **Dr. De Jong** and **Dr. Bakker** in 2006, although some structural stress is apparent.
- We have consulted Mr. Miller (ASAPA member 087) concerning your now redundant demolition permit's conditions regarding the excavation of the site and the repository of possibly recovered artefacts and related finds.

- 4.a. That the permit committee of Heritage Free state review the situation and hopefully re-issue a *provisional demolition* permit.
- 4.b. That an *excavation* permit is provided by Heritage Free state for formalising the legalities regarding excavation in South Africa.

5. Also for consideration of the permit committee we undertake to execute the following actions so as to preserve the memory of the 1906 Voorspoed diamond mine:

- 5.a. That the excavation will provide a layout plan of the village by determining the positions of the foundations of the buildings.
- 5.b. That a midden will be excavated so as to provide an insight into the cultural material of the people that inhabited the village.
- 5.c. That the heritage impact assessments, phases I, II and III, photographs in possession of Voorspoed mine management and the excavation results will be collated into a small publication.
- 5.d. That a granite, lazer printed commemoration plaque will be erected at an appropriate position on the mining site that will compliment the eventual rehabilitation of the present mine at its closure.

We look forward to your favourable response.

Detail the manner in which the proposed work is carried out:

A level 2 Heritage Impact Assessment (HIA) of the historical building as provided for in Section 38 of the National Heritage Resources Act (Act 25 of 1999) was conducted by Dr RC de Jong and Prof Karel Bakker of Cultmatrix in Sep 2005.

The historical building will be totally demolished during the construction phase of the Voorspoed Mine as part of the site preparation.

Motivation for Proposed work (please motivate fully, with reference to conservation principles where appropriate. This space may also be used for additional details required above.)

The Level 2 Heritage Impact Assessment conducted by Cultmatrix recommended that permission for demolition of the historical building should be granted for the following reasons:

- The building cannot be preserved because it falls within the extent of the open pit extension and associated surface infrastructure (roads and storm water management facilities).
- In terms of the benefits of economic development and job creation associated with the reopening of the mine in relation to the benefit associated with the conservation of the building, there are no compelling reasons to retain the building.
- The condition of the building does not merit its continued conservation the loss of heritage fabric is permanent.

Approximate value of proposed work: Not applicable – the building will be demolished as part of the general construction activities during the establishment of the mine.






