Notice is given in terms of the amended Environmental Impact Assessment (EIA) Regulations, under sub-regulation 41 (2) (a), published in Government Gazette (GG) No 40772 of 7 April 2017, of the National Environmental Management Act 1998 (Act No. 107 of 1998, as amended) (NEMA), that ABO Wind Renewable Energies (Pty) Ltd, supported by Veroniva (Pty) Ltd (hereinafter referred to as "Veroniva") proposes to construct and operate 3 x 115 Megawatt (MW) Solar Photovoltaic (PV) Facilities and associated electrical infrastructure near Vryburg in North West. The proposed Solar Facilities will be connected to the Mookodi Substation via 132 kV distribution lines for each 115 MW Facility. The proposed Facilities will be constructed on two land portions, namely Portion 2 of Frankfort Farm 672 and Portion 1 of Retreat Farm 671, with the distribution lines also traversing Portion 0 and Portion 1 of Frankfort Farm 672, and Remainder of Rosendal Farm 673. The proposed project site is located approximately 8 km south-west of Vryburg.

The projects are located in the Vryburg Renewable Energy Development Zone (REDZ). The REDZs represent areas where wind and solar photovoltaic development is being incentivised from resource, socio-economic and environmental perspectives. The Wind and Solar SEA REDZs were identified in five provinces, including North West, as defined in Notice No. 114 – *Notice for Renewable Energy Development Activities procedure to apply for Environmental Authorisation* - in Government Gazette No 41445 of 16 February 2018.

In terms of the National Environmental Management Act (Act 107 of 1998, as amended) (NEMA) and the 2014 NEMA EIA Regulations promulgated in Government Gazette 40772 and Government Notice (GN) R326, R327, R325 and R324 on 7 April 2017, wind and solar PV projects located within a REDZs are subject to a Basic Assessment (BA) Process. The need for a BA is triggered by the following activities listed in GNR 324, 325 and 327: *GNR 327; Activity 11, 28(ii) and 47, GNR 325; Activity 1 and 15 and GNR 324; Activity 4 and 12.*

The projects are located in the Vryburg Renewable Energy Development Zone (REDZ). In terms of the NEMA and the NEMA EIA Regulations promulgated in Government Gazette 40772 and Government Notice (GN) R326, R327, R325 and R324 on 7 April 2017, wind and solar PV projects located within a REDZs are subject to a Basic Assessment (BA) Process. The CSIR has been appointed by Veroniva to undertake the required BA Process for the proposed projects. However, separate Applications for Environmental Authorisation (EA) will be lodged with the Competent Authority (i.e. the National Department of Environmental Affairs (DEA)) for each proposed Solar PV Facility and transmission line. Separate Basic Assessment Reports will be compiled for each project.

**Request for 1) Pre-Application Correspondence and/or 2) Pre-Application Meeting with the Department of Environmental Affairs (DEA) for the Proposed Vryburg Solar 1, 2 and 3 Photovoltaic (PV) Facilities**

#### **1. Pre-Application Correspondence**

The Applicant wishes to commence with the Basic Assessment (BA) Processes (listed below) as soon as possible based on the timeframes of the next bidding round of the Renewable Energy Independent Power Producer Procurement Programme (REIPPPP). Based on the time limitations associated with the REIPPPP, the Applicant wishes to release the Draft BA Reports by 03 August 2018. However, we understand that communication with the DEA prior to submission of the Application Form and Draft BA Report is important, and we would still like to achieve this communication in the most efficient manner, which will also assist us with finalising the Draft BA Report (DBAR) for release for Stakeholder and Public Comment. We have therefore captured a few notes or queries below, that we hope the DEA would consider and provide us with feedback as soon as possible, i.e. by 01 August 2018? If there are no major changes required, we would then proceed with the 03 August submission of the Application and release of the DBAR.

#### **Background and Location:**

ABO Wind Renewable Energies (Pty) Ltd with support from Veroniva (Pty) Ltd (the project developers), are proposing to develop three 115 MW Solar PV Facilities and associated electrical infrastructure (including a 132 kV distribution line from each PV Facility to the Eskom Mookodi Substation), near Vryburg in the North West Province. The proposed projects are referred to as "Vryburg Solar 1, Vryburg Solar 2, and Vryburg Solar 3". The Applicants will be: Vryburg Solar 1 (Pty) Ltd; Vryburg Solar 2 (Pty) Ltd; and Vryburg Solar 3 (Pty) Ltd.

The proposed projects will occur on the following farm portions (as shown in the attached Pre-application meeting request form and locality map):

- Portion 1 of Farm Retreat Number 671
- Portion 0 (Remaining Extent) of Farm Frankfurt 672
- Portion 1 of Farm Frankfurt Number 672 ("Edin")
- Portion 2 of Farm Number 672 ("Erica")
- Remainder of Farm Rosendal 673, IN

The proposed projects fall entirely within the Renewable Energy Zone (REDZ) 6 (i.e. Vryburg REDZ), that was Gazetted in February 2018 by the Minister of Environmental Affairs. As noted in Government Notice 114, a BA Process in terms of Appendix 1 of the EIA Regulations (2014, as amended) will be undertaken for the proposed project, with a 57 day decision-making timeframe.

#### **Specialist Studies:**

The following specialist studies have been commissioned as part of this BA Process:

- Visual Impact Assessment
- Heritage Impact Assessment: Archaeology and Cultural Landscape
- Heritage Impact Assessment: Palaeontology
- Soils and Agricultural Potential Assessment
- Ecological Assessment (Terrestrial and Aquatic Ecology)
- Social Impact Assessment
- Avifauna Assessment
- Traffic Impact Statement

A Traffic Impact Statement will be compiled by CSIR and peer reviewed by an external traffic engineer, as successfully done for previous EIA and BA Projects for similar PV projects.

The above list of specialist studies has been commissioned based on the issues that are linked to the proposed Solar PV development in the Vryburg area, findings from the Strategic Environmental Assessment (SEA) that informed the Gazetting of the REDZs, as well as based on research undertaken of similar projects surrounding the proposed project, including our previous experience in Solar PV EIAs and BAs. We believe that the specialist studies captured above are comprehensive and best suited to cover the range of issues and impacts linked to the proposed projects.

Please could the DEA confirm that the specialist studies listed above are sufficient?

#### **Cumulative Impacts:**

For the approach to cumulative impacts for the proposed Vryburg Solar PV projects, we will consider the renewable energy projects within a 30 km radius of the proposed sites that have a positive Environmental Authorisation (EA) issued at the start of these BA Processes (i.e. 18 June 2018), based on an internet search and egis data.

The main reasons for this approach are:

1. The 30 km radius was approved by the DEA for other recent and similar projects undertaken by the CSIR (i.e. there is a reasonable precedent).
2. For projects where an EA may have started, there is no guarantee that these projects will receive EA, nor is there a guarantee of the extent of the project that may be authorised (i.e. only a portion of the project component could be authorised).
3. For projects where an EA may have started or is in progress, the project description may still change; hence a definitive approved project description cannot be used in the assessment of cumulative impacts.
4. Even if a project receives an EA, there is no guarantee that it will be awarded preferred bidder status under the REIPPPP. Experience from the renewable energy program to date shows that only approximately 10% to 20% of projects with positive Environmental Authorisations have been awarded preferred bidder status. However, we are still adopting a precautionary approach by considering all renewable energy projects within a 30 km radius of the proposed sites with a positive EA as at 18 June 2018.

In addition, some of the specialists will still consider the other renewable energy projects with EIAs and BAs in progress within a 30 km radius, and add a statement regarding this in their reports.

#### **2. Pre-Application Meeting Request**

Based on previous discussions with representatives from the Integrated Environmental Authorisation (IEA) Directorate of the DEA, venue availability at the DEA offices is a potential limitation. Therefore, it is recommended that the pre-application meeting be held via [teleconference](#), in order to maximise efficiency and contribute to sustainability by reducing travel to Pretoria. If the pre-application meeting cannot take place via teleconference, it is recommended that the meeting take place at the CSIR Offices in Pretoria, to assist the DEA with regards to logistics.
