NOTICE FOR A BASIC ASSESSMENT PROCESS TO OBTAIN ENVIRONMENTAL AUTHORISATION FOR THE PROPOSED COAL WASHING PLANT ON PORTION 44 OF THE FARM NOOITGEDACHT 388 – HR, NEAR THE TOWN VRYHEID, ABAQULUSI LOCAL MUNICIPALITY, KWAZULU NATAL PROVINCE

#### 1. PURPOSE OF THIS DOCUMENT

The purpose of this document is to provide:

- A description of the required environmental authorisation processes.
- A description of the required public participation processes.


### 2. PROJECT BACKGROUND

Restimanzi (Pty) Ltd appointed Water Use Licence Associates (Pty) Ltd to undertake a Basic Assessment Application for the proposed coal washing plant on Portion 44 of the Farm Nooitgedacht 388-HR, near Vryheid, KwaZulu-Natal.

The project entails the construction of a coal washing plant. The infrastructure associated with the coal washing plant will include stockpile areas, a washing plant, water storage containers and dry beds.

## 3. LOCATION

# 4. <u>REGULATORY REQUIREMENTS AND</u> PROCESS

The proposed coal washing plant will trigger listed activities in terms of the Environmental Impact Assessment Regulations, 2014, as amended (2017) and promulgated in terms of Chapter 5 of the National Environmental Management Act, 1998 (Act No. 107 of 1998). The following listed activity may apply triggering the need for a Basic Assessment (BA) process:

#### **LISTING NOTICE 1 (GN R.327)**

#### Activity 27:

The clearance of an area of 1 hectare or more, but less than 20 hectares of indigenous vegetation.

The competent regulatory authority for the application is the KwaZulu Natal Department of Agriculture and Environmental Affairs.

## 5. POTENTIAL IMPACTS

Positive impacts and negative impacts may derive during the construction and operational phases of the proposed project.

Some of the impacts identified include:

# **Positive Impacts:**

**Social Inputs:** Employment opportunities created during the construction phases of the project.

**Economic Inputs:** The project will promote the economic growth of the local economy during the construction and operational phases.

**Biodiversity:** The project will provide opportunities to manage alien invasive species by implementing an alien invasive control and eradication plan.

# **Negative Impacts:**

**Biodiversity:** Clearance of vegetation may result in loss of species habitat and species if not properly managed.

Pollution: Dust pollution and noise pollution.

The specialist studies to be undertaken include:

 Delineation and brief characterisation of watercourses within 500m of the facility;

- Terrestrial verification assessment;
- · Heritage Impact assessment;
- Paleontological Impact assessment;
- · Geohydrological Assessment; and
- Engineering reports and designs.
