## **ENVIRONMENTAL ASSESSMENT PROCESS**

In accordance with the Environmental Impact Assessment (EIA) Regulations, 2014 (as amended) published in terms of Section 24(5) of the National Environmental Management Act (No. 107 of 1998) (NEMA), the applicants require Environmental Authorisation (EA) from the National Department of Environment, Forestry and Fisheries (DFFE) in consultation with the Northern Cape Department of Agriculture, Environmental Affairs, Rural Development and Land Reform (DAEARD&LR) for the development of the proposed projects. In terms of Sections 24 and 24D of the National Environmental Management Act (No 107 of 1998), as read with the EIA Regulations, GNR 982-985 of 4 December 2014, as amended, a Basic Assessment process is required to be undertaken in support of an application for authorisation for the each of the proposed grid connections associated with the four (4) solar developments. Each application is required to be supported by comprehensive, independent environmental studies undertaken in accordance with the EIA Regulations, 2014 (as amended).

The proponent has appointed Savannah Environmental, as the independent environmental consultant to undertake the BA processes for the projects to identify and assess all potential environmental impacts associated with the projects and recommend appropriate mitigation measures in the Environmental Management Programmes (EMPrs).

You and/or the organization/company, which you represent, have been identified as a stakeholder for the proposed projects as described above. The nature and extent of the EGIs and associated infrastructure are explored in more detail in the BID which was distributed in March 2022 and is attached to this letter and is also available for download from the Savannah Environmental website.

## **PUBLIC INVOLVEMENT PROCESS**

The public participation (PP) process will be undertaken in accordance with the requirements of Regulations 39 to 44 of the Environmental Impact Assessment (EIA) Regulations, 2014, as amended, (GNR 326). The aim of the public participation process is primarily to ensure that:

- » information containing all relevant facts in respect of the proposed project is made available to potential stakeholders and I&APs;
- » participation by I&APs is facilitated in such a manner that all potential stakeholders and I&APs are provided with a reasonable opportunity to comment on the proposed project; and
- » comments received from potential stakeholders and I&APs are recorded and incorporated into the EIA process.
