So when this limit was achieved nothing less than the 8 grams per ton was mined. With a change in economics the gold price is considerably higher and therefore the break even threshold has changed accordingly. This allows for additional mining operations to take place. If the economics change and the gold price goes up even the tailings that lies on surface becomes viable to mine. And that is why the DMR classifies the tailings as a resource. Because the economics allows it to be reprocessed. If you have ore of a certain grade lying on surface you don't have to spend a lot of money to mine it. There are a lot of gold reefs in South Africa that weren't mined out. Through a hundred years of mining the knowledge of what was left is available. It was put on plans and those plans are available and can be accessed.

The prospecting right was issued for a period of 5 years and carried on until 2011, at which point an extension to the prospecting right was applied for. That extension was granted in 2013 for a period up until April 2019. So the prospecting right is valid until April 2019. West Wits on its own has spent in the order of R10 million on prospecting related activities. I have prior knowledge that the funds were put in and the rehabilitation and closure to the prospecting was done.
