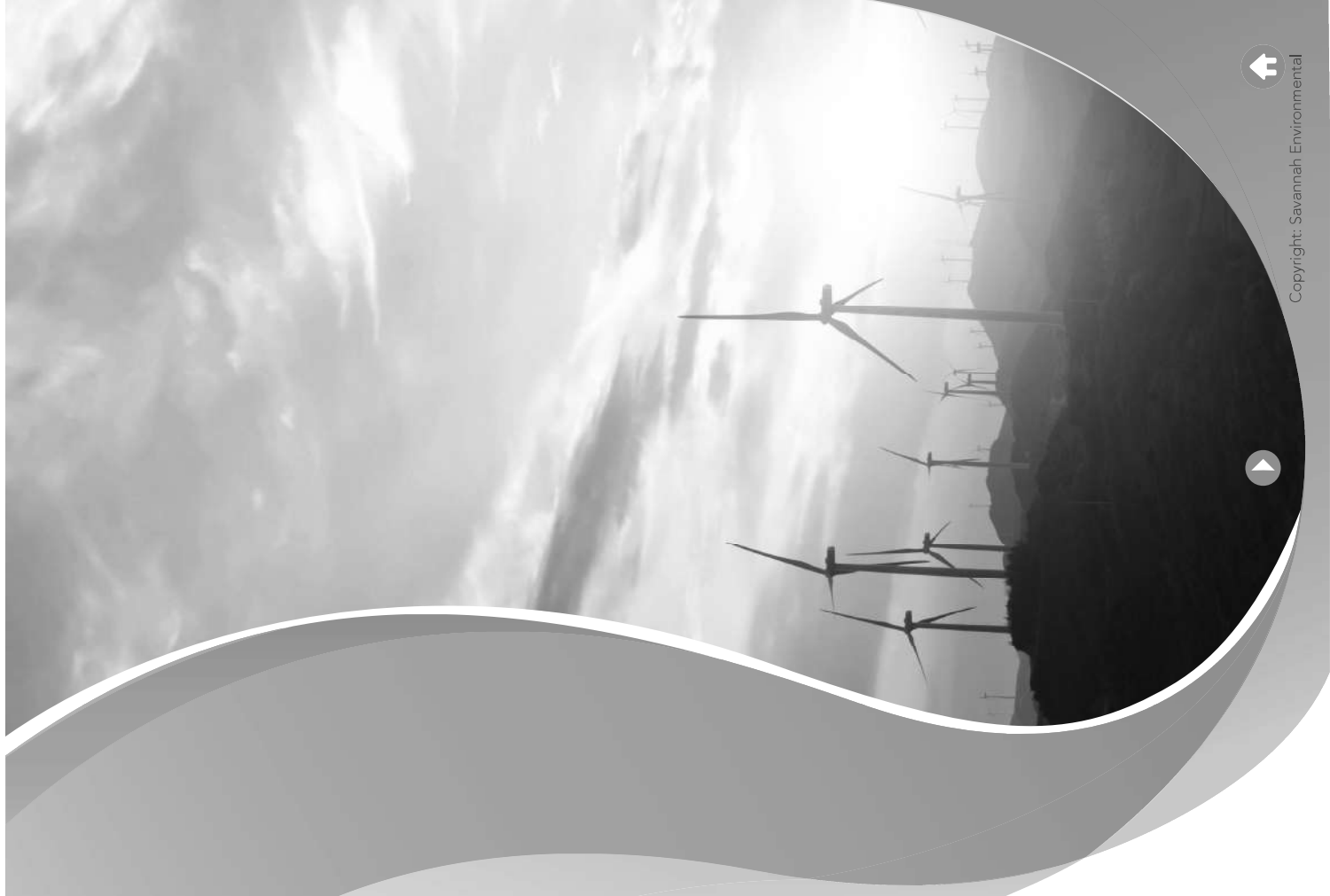

### WHAT IS WIND ENERGY?

Wind energy is the use of the wind as an energy source. A wind energy system transforms the moving (kinetic) energy of the wind into mechanical or electrical energy that can be harnessed for practical use. Harnessing the wind for electricity generation is the most commonly known form of renewable energy today.

### HOW DOES A WIND TURBINE WORK?

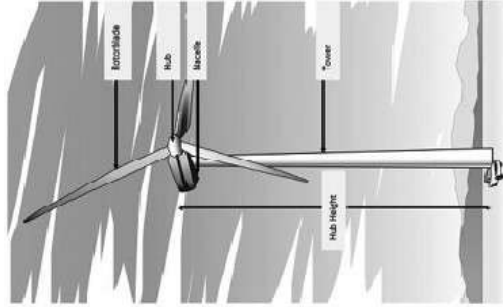


Figure 1: Main components of a wind turbine

Wind turbines use the energy from the wind to generate electricity. A wind turbine consists of four large main components (Figure 1):

- » The rotor
- » The nacelle
- » The tower
- » The foundation unit

The wind blows through blades, which converts the wind's energy into electricity via a generator located in the nacelle. Turbines are able to operate at varying speeds. The amount of energy a turbine can harness depends on both the wind velocity (strength) and the length of the rotor blades. The turbines being considered for use at the Wind Garden and Fronteer wind farms will range between 4.2MW up to 5.6MW.

### HOW ARE THE NUMBER OF TURBINES FOR THE PROJECT DETERMINED?

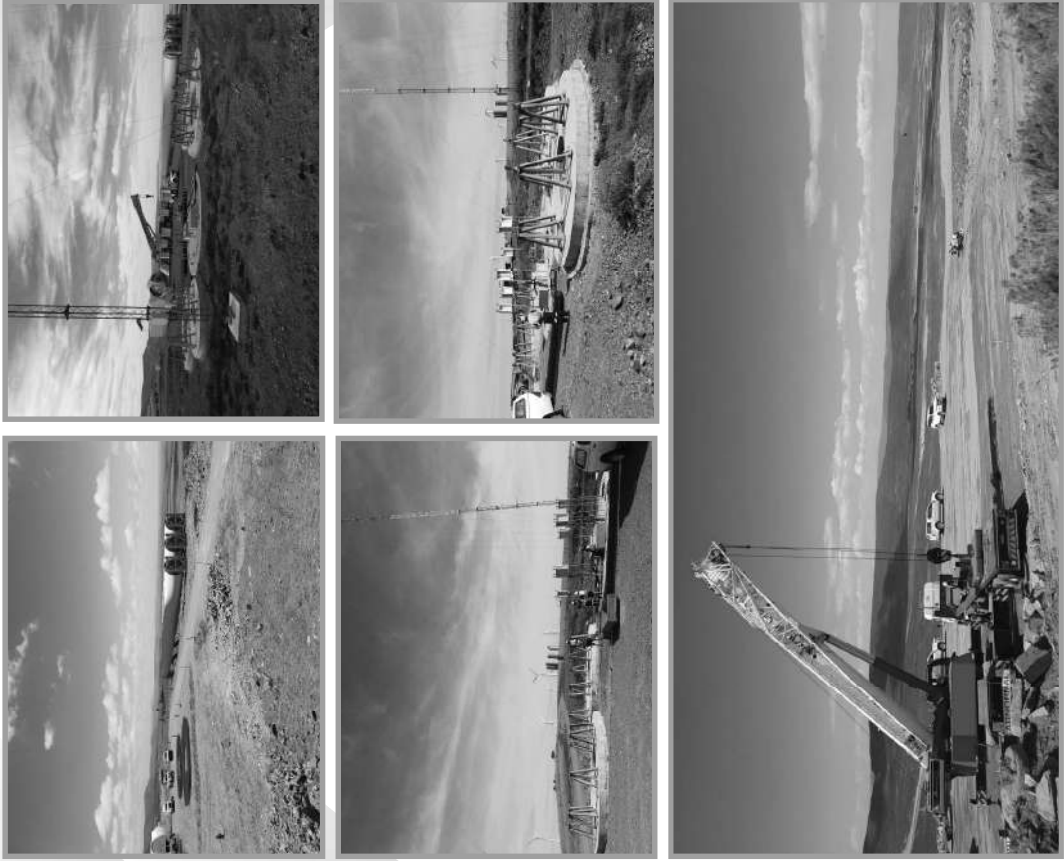
Various wind turbine designs and layouts on the project sites are being considered by the project developer in order to maximise the generating capacity of the sites while minimising any negative environmental impacts. The final facility layouts, turbine capacities and models will be dependent on what is deemed suitable for the project sites in relation to, among other things, further studies of the wind regime (i.e. seasonal), terrain, and environmental constraints and social sensitivities.

### HOW ARE WIND FARMS CONSTRUCTED?

The length of the construction period for each of the wind farms is estimated to be approximately 30 months (2 ½ years). A turbine is designed to operate continuously, with low maintenance for 20 to 25 years. Direct and indirect job opportunities will be created during both construction and operation. The photos below show what the construction of a wind farm similar to Wind Garden and Fronteer looks like.

### WHAT IS THE WIND ENERGY FACILITY LIKELY TO LOOK LIKE?

The below pictures show what the wind farm may look like within the area.

View towards Wind Garden Wind Farm looking south-east from within the site. The closest wind turbine is 400m from this point.



View towards Fronteer Wind Farm looking north-west from the R350 near Makhanda. The closest wind turbine is 3.8km from this point.



### HOW IS A SITE FOR WIND DEVELOPMENT CHOSEN?

In order to determine a feasible development site, the following measures are taken into account during the planning phase:

Technical Issues:

The developer looks at key aspects such as:

- Wind speed (strength and consistency per season)
- Topography of the land / property (Flat areas would be preferred if the wind resource was good as it is easier to build there)
- Geological features of the land / property i.e. importance of good founding conditions for the turbine base.
- Grid connection – how close / far is it to the nearest Eskom grid network and the available capacity on the preferred line.

Environmental Issues: including the sensitivity of both the natural and social environments to guide the development in the area. These are investigated during the planning phase through an Environmental Impact Assessment (EIA) by independent environmental specialists in various fields such as visual, social, biodiversity, etc to provide an understanding of the sensitivity of both the natural and social environments to guide the development in the area. Savannah Environmental has been appointed as the independent consultant for these projects. A team of specialists has been appointed to complete the relevant detailed studies to inform the conclusion on the projects. The Department of Forestry, Fisheries and

Environment (DFFE) is responsible for making a decision on the environmental acceptability of the project.

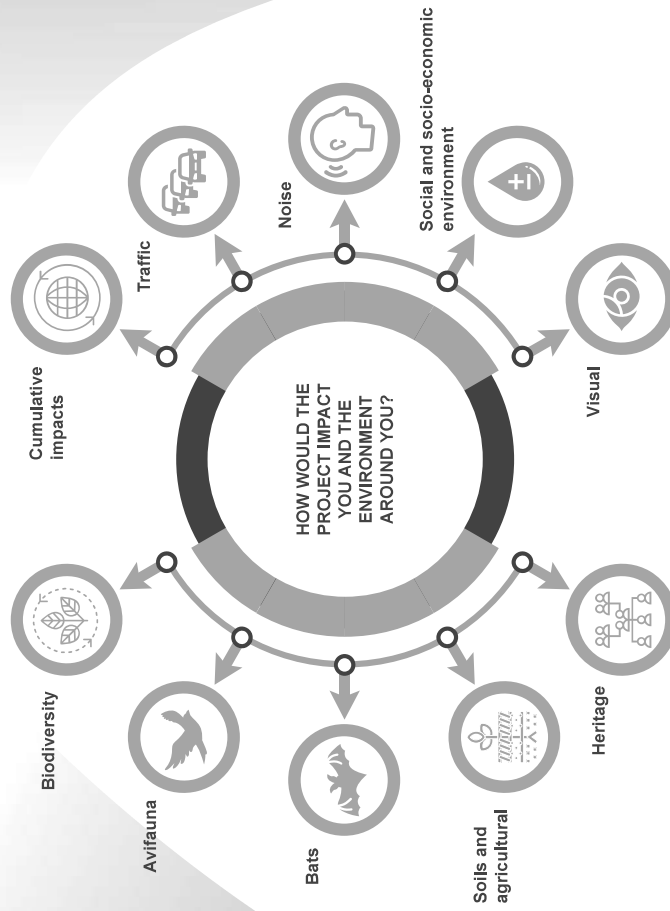
Public issues and acceptance / rejection: the public's perception of the proposed wind energy facility and the appropriateness of the development in the area. This is determined through the public participation process undertaken as part of the EIA investigations. It is important to obtain local knowledge and inputs regarding the developments from the affected and surrounding communities and/or occupiers of the properties. Issues and/or comments raised (negative as well as positive) are recorded and included in the reports and submitted to the DFFE to make an informed decision on the project acceptability.

Economics: Including both the costs and benefits to the developers and the public. For this project the electricity generated will be sold to private businesses / companies resulting in alleviating the electricity load on Eskom's network which could result in more electricity capacity availability to us as end users.



## HOW WOULD THE PROJECT IMPACT YOU AND THE ENVIRONMENT AROUND YOU?

Based on the type of project proposed and its location, the nature of the affected area, and experience of the consultants on similar projects and their local knowledge of the study area, a number of potential impacts on the natural and social environment associated have been identified and investigated. The following are being fully assessed through separate specialist studies for each project:

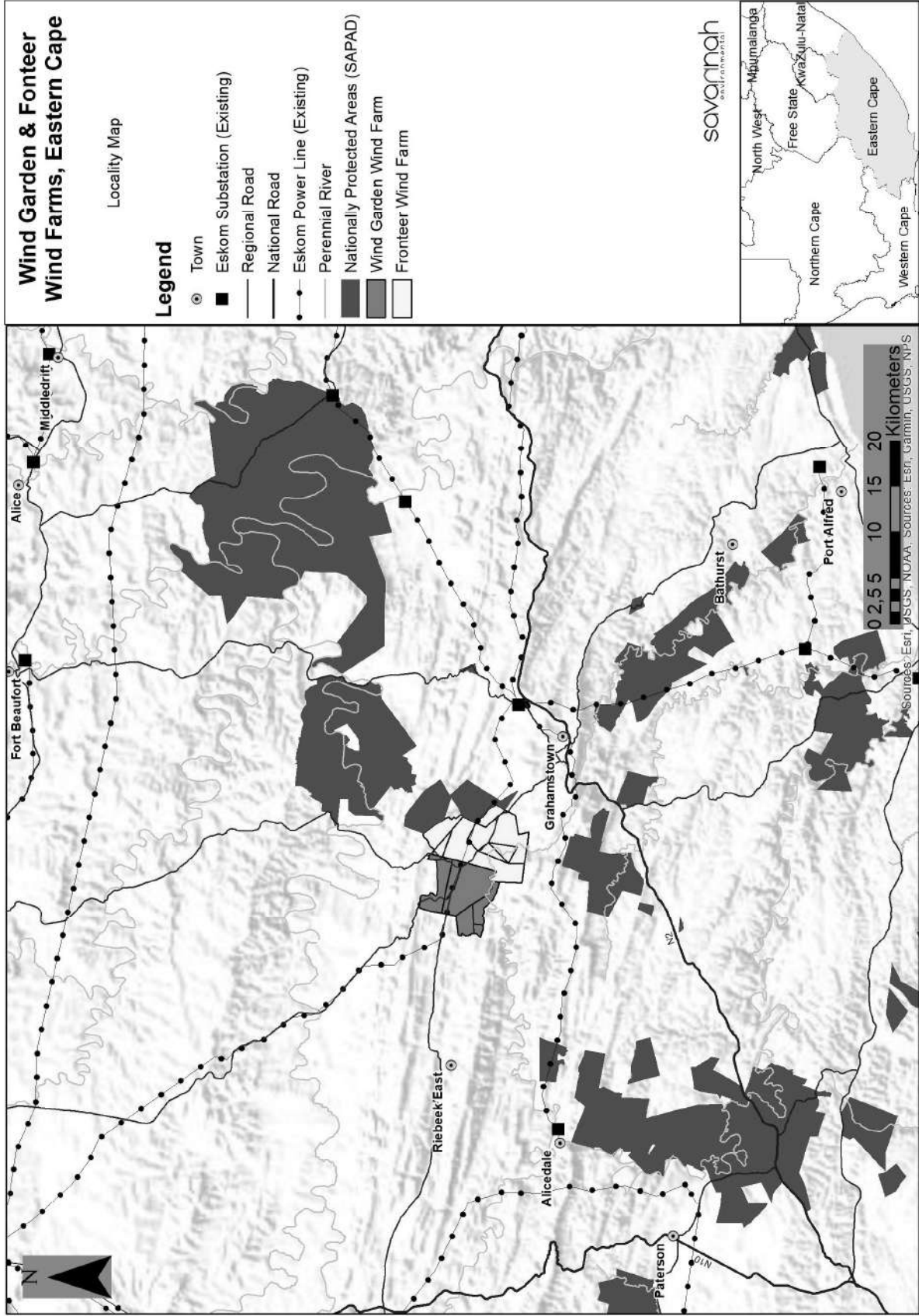

Savannah Environmental (Pty) Ltd is managing an Environmental Impact Assessment (EIA) process for the proposed development of the Frontier Wind Farm and associated infrastructure on a site near Makhanda (Grahamstown), Eastern Cape Province (DEA Ref. No.: 14/12/16/3/3/1/2315). The EIA process is being conducted in accordance with the National Environmental Management Act (No. 107 of 1998) (NEMA) and the 2014 EIA Regulations (GNR 326) ("the EIA Regulations"). Due to the geographical location of the project site within the Cookhouse Renewable Energy Development Zone ("REDZ"), one of the eight designated REDZ areas, the Frontier Wind Farm ("the project") is subject to a Basic Assessment ("BA") as prescribed in GNR 114 of 16 February 2018.

A Basic Assessment Report was prepared by Savannah Environmental and made available for a 30-day public review period from **04 March 2021 – 07 April 2021**. At the request of Interested and Affected Parties ("I&APs"), this review period was extended to **06 May 2021**, resulting in a 60-day review period being afforded for the public participation process.

In order for the project applicant and Savannah Environmental to adequately address the comments received from I&APs as part of the EIA process, the Basic Assessment Report was revised, and the revised BAR made available for public review and comment. The I&APs were provided with a further 30-day period from **21 June to 21 July 2021** to comment on the revised BAR. All changes made within the revised BAR have been underlined for ease of reference.

At a meeting held for the project on 07 July 2021, several I&APs requested an extension of this 30-day review period in order to enable them to review the revised BAR. They have requested that the period be extended to 21 August 2021.

In terms of the regulated timeframes for the Basic Assessment process (including the extension of the timeframe in terms of Regulation 19(1)(b)) (as acknowledged by yourselves on 18 May 2021), we are required to submit the final BAR to your Department within 140 days of submission of the application, i.e., 28 July 2021. Therefore, if this requested extension is granted, we would fail to meet the regulated timeframe.

The applications for Environmental Authorisation and draft Basic Assessment Report (BAR) received by this Department on 04 March 2021, the acknowledgement letter dated 08 March 2021, the comments on the draft BAR dated 01 April 2021, your request for extension in terms of Regulation 19 (1)(b) of the EIA Regulations, 2014, as amended dated 14 May 2021 and the request for extension letter in terms of Regulation 3(7) of the EIA Regulations, 2014, as amended received on 12 July 2021, refer.

A Basic Assessment Report was prepared by Savannah Environmental and made available for a 30-day public review period from 04 March 2021 – 07 April 2021. At the request of Interested and Affected Parties ("I&APs"), this review period was extended to 06 May 2021, resulting in a 60-day review period being afforded for the public participation process.

In order for the project applicant and Savannah Environmental to adequately address the comments received from I&APs as part of the EIA process, the Basic Assessment Report was revised, and the revised BAR made available for public review and comment. The I&APs were provided with a further 30-day period from 21 June to 21 July 2021 to comment on the revised BAR.

This Department received correspondence in the form of a letter from the Savannah Environmental (Environmental Assessment Practitioner/EAP) on behalf of the applicant, Wind Garden (Pty) Ltd., on 12 July 2021 requesting an extension of the prescribed one hundred and forty (140) days timeframe (including the extension of the timeframe in terms of Regulation 19(1)(b)) (as acknowledged by this Department on 18 May 2021), within which the final BAR were to be submitted to the Department.

Based on the information received from the Environmental Assessment Practitioner (EAP), the extension is requested based on the following statements –

- At a meeting held for the project on 07 July 2021, several Interested and Affected Parties (I&APs) requested an extension of this 30-day review period in order to enable them to review the revised BAR. They have requested that the period be extended to 21 August 2021.

Regulation 3(7) of the EIA, 2014, as amended states that ***“In the event where the scope of work must be expanded based on the outcome of an assessment done in accordance with these Regulations, which outcome could not be anticipated prior to the undertaking of the assessment, or in the event where exceptional circumstances can be demonstrated, the competent authority may, prior to the lapsing of the relevant prescribed timeframe, in writing, extend the relevant prescribed timeframe and agree with the applicant on the length of such extension.”***

Based on the motivation provided by the EAP, this Department has decided **not to grant** the extension of the timeframes to submit the final BAR within 185 days (i.e. additional 45 days) from the date of submission of the application.

Regulation 45 of the EIA Regulations, 2014, as amended states that ***“An application in terms of these Regulations lapses, and a competent authority will deem the application as having lapsed, if the applicant fails to meet any of the time-frames prescribed in terms of these Regulations, unless extension has been granted in terms of regulation 3(7).”***

As such, this Department hereby advises that you must submit the final BAR in terms of Regulation 19(1). Failure to submit the final BAR in terms of Regulation 19(1), will result in the applications lapsing in terms of Regulation 45.

You are hereby reminded of Section 24F of the National Environmental Management Act, Act No 107 of 1998, as amended, that no activity may commence prior to an environmental authorisation being granted by the Department.

The applications for Environmental Authorisation and draft Basic Assessment Report (BAR) received by this Department on 04 March 2021, the acknowledgement letter dated 08 March 2021, the comments on the draft BAR dated 01 April 2021, your request for extension in terms of Regulation 19 (1)(b) of the EIA Regulations, 2014, as amended dated 14 May 2021 and the request for extension letter in terms of Regulation 3(7) of the EIA Regulations, 2014, as amended received on 12 July 2021, refer.

A Basic Assessment Report was prepared by Savannah Environmental and made available for a 30-day public review period from 04 March 2021 – 07 April 2021. At the request of Interested and Affected Parties ("I&APs"), this review period was extended to 06 May 2021, resulting in a 60-day review period being afforded for the public participation process.

In order for the project applicant and Savannah Environmental to adequately address the comments received from I&APs as part of the EIA process, the Basic Assessment Report was revised, and the revised BAR made available for public review and comment. The I&APs were provided with a further 30-day period from 21 June to 21 July 2021 to comment on the revised BAR.

This Department received correspondence/notification in the form of a letter from the Savannah Environmental (Environmental Assessment Practitioner/EAP) on behalf of the applicant, Fronteer (Pty) Ltd., on 12 July 2021 requesting an extension of the prescribed one hundred and forty (140) days timeframe (including the extension of the timeframe in terms of Regulation 19(1)(b)) (as acknowledged by this Department on 18 May 2021), within which the final BAR were to be submitted to the Department.

Based on the information received from the Environmental Assessment Practitioner (EAP), the extension is requested based on the following statements –

- At a meeting held for the project on 07 July 2021, several Interested and Affected Parties (I&APs) requested an extension of this 30-day review period in order to enable them to review the revised BAR. They have requested that the period be extended to 21 August 2021.

Regulation 3(7) of the EIA, 2014, as amended states that ***“In the event where the scope of work must be expanded based on the outcome of an assessment done in accordance with these Regulations, which outcome could not be anticipated prior to the undertaking of the assessment, or in the event where exceptional circumstances can be demonstrated, the competent authority may, prior to the lapsing of the relevant prescribed timeframe, in writing, extend the relevant prescribed timeframe and agree with the applicant on the length of such extension.”***

Based on the motivation provided by the EAP, this Department has decided **not to grant** the extension of the timeframes to submit the final BAR within 185 days (i.e. additional 45 days) from the date of submission of the application.

Regulation 45 of the EIA Regulations, 2014, as amended states that ***“An application in terms of these Regulations lapses, and a competent authority will deem the application as having lapsed, if the applicant fails to meet any of the time-frames prescribed in terms of these Regulations, unless extension has been granted in terms of regulation 3(7).”***

As such, this Department hereby advises that you must submit the final BAR in terms of Regulation 19(1). Failure to submit the final BAR in terms of Regulation 19(1), will result in the applications lapsing in terms of Regulation 45.

You are hereby reminded of Section 24F of the National Environmental Management Act, Act No 107 of 1998, as amended, that no activity may commence prior to an environmental authorisation being granted by the Department.

The following concerns were raised in the first (1) information session (Mr White's Farm)

- » Ward Councilor: Ms. Phumelele, she is hardly seen so they don't have any other information about her

## **Session 2**

The following concerns were raised in the second (2) information session (Mr Angus Farm)






- » They are protecting their jobs because, the wind turbines will discourage people from coming and visit their game reserve, which will in turn affect their jobs and livelihoods. There are a lot of wind turbines proposed which will distract their visitors from peace of mind they normally look for (nature)
- » What other things that are people getting during the maintenance phase?
- » Most times there are lights flashing for example, in the farms near Grahamstown, those lights are disturbing especially at night.
- » We have spent most of our lifetime trying to keep this place as natural as possible, with no infrastructure, I am imagining the amount of the environment that will be destroyed from making roads to making sure that the construction phase is running well.
- » The animal movements and habitat will be disturbed because they will be scared to move around or near wind turbines.
- » How much more are you willing to invest on road construction as we maintain the roads ourselves. There will be a lot of damage to our roads due to trucks movements.
- » Even during the road construction to the wind turbines, a lot of vegetation that we are supposed to protect will be destroyed.
- » Our animals are free and are not used to noise, which construction will make. They will go away and hide, and when we need to drive our guest around the reserve, the animals re not there and they will leave and never recommend us to any more guest. Also note that, our business is very much dependent (about more that 90%) on international guest which leave their countries to just enjoy nature and also because they are also running away these things like infrastructure.
- » The machines may affect the wires and our animals may escape, and the larger Grahamstown community will be affected, which then gets back to us, as our animal will be roaming outside the reserve.
- » The wind turbines will affect people's lives negatively, because if the business side of the tourism is affected people's jobs will be affected. Most people who work for us are from Grahamstown.
- » Having many coming in and out will increase the rate of crime in our reserve. How will you ensure our safety?
- » Are there no other ways of generating electricity other than wind for example, water or sun using solar? Can these wind turbines be made shorter?
- » Feedback on all these concerns was requested.


