

Project Name: Winterveld Extension 5.

Proponent: City of Tshwane Metropolitan Municipality (Maluleke, Luthuli Development Planners (Pty) Ltd originally acted on behalf of the CTMM but the application form was amended and the CTMM now act as the applicant in their own capacity).

Project & Property Description: The proposed project is for the establishment of a Township to be known as Winterveld Extension 5 in collaboration with the City of Tshwane Metropolitan Municipality. It aims to serve as a Mixed-Use Development (Residential 3, Residential 5, Business 1, Institutional, Educational, Infrastructure Works, and Public Open Space) on the remaining extent of Holdings 1418 to 1472, 1541 to 1570, and 1573 to 1589, Winterveld Agricultural Holdings Extension 1, City of Tshwane Metropolitan Municipality, Gauteng Province.

Location: The proposed development is situated north of Mabopane and west of Soshanguve between Bushveld Road, Phalama Road, First Road, and Makgatho Road, and forms part of the larger Winterveld development region.
