Project description

The project entails the Construction of a 45m Lattice Mast within the footprint size of 10m x 10m area and a support container.

The site is to accommodate three service providers.

Project locality

The site is situated approximately 6,7km west of the R51 and 8,7km north east of the R23, Lesedi Local Municipality. The specific position where the mast is proposed to be erected is on the side slope of a koppie to the east of an existing commercial use.

Regulatory Process

In terms of the National Environmental Management Act, 1998 (Act No 107 of 1998) and associated EIA Regulations published during 2014 (as amended 2017), an Environmental Authorisation should be obtained from the relevant decision making authority, prior to the commencement of certain listed activities that may result in potential negative impacts on the environment.
