AMENDMENT OF THE ENVIRONMENTAL AUTHORISATION ISSUED ON 29 MARCH 2018 FOR THE PROPOSED CONSTRUCTION OF THE 235MW !XHA BOOM WIND ENERGY FACILITY (WEF) AND ASSOCIATED INFRASTRUCTURE SITUATED NEAR LOERIESFONTEIN, HANTAM LOCAL MUNICIPALITY IN THE NORTHERN CAPE PROVINCE

The Environmental Authorisation (EA) issued for the abovementioned application by this Department on 29 March 2018, subsequent EA amendments issued on the 13 May 2019 and 09 March 2020, and your application for amendment of the EA received by the Department on 18 June 2021, and the acknowledgement letter dated 24 June 2021, refer.

Based on a review of the reason for requesting an amendment to the above EA, this Department, in terms of Chapter 5 of the Environmental Impact Assessment Regulations, 2014 as amended, has decided to amend the EA dated 29 March 2018, as follows:

Reason for amendment:

South Africa Mainstream Renewable Power Developments (Pty) Ltd transferred the rights to the Environmental Authorisations and associated amendments mentioned above to !Xha Boom Wind Farm (Pty) Ltd, a fully owned subsidiary of Mainstream.

Amendment 2: Amendment of project name

The project name on page 1; the property description on page 7; and condition 1 on page 8 of the EA:

"...construction of the !Xha Boom Wind Farm near Loeriesfontein, Hantam Local Municipality in the Northern Cape Province..."

Is hereby amended to:

"...construction of the 235MW !Xha Boom Wind Energy Facility (WEF) and associated infrastructure situated near Loeriesfontein, Hantam Local Municipality in the Northern Cape Province..."

Reason for amendment:

The project name needs to be amended to include "associated infrastructure" due to the inclusion of the BESS.

Amendment 3: Inclusion of the Battery Energy Storage System (BESS):

a) The following coordinates for the proposed BESS facility is added on page 07 of the EA:

c) Condition 13.2 on page 10 of the EA:

"Substation(s) inverters and/or transformer(s) sites including their entire footprint;"

Is hereby amended to:

"Substation(s) inverters and/or transformer(s) sites, Battery Energy Storage system sites, including their entire footprint"

Reason for amendment:

To ensure adequate energy supply of electricity from the wind farm, !Xha Boom is proposing the addition of a Battery Energy Storage System (BESS) with a capacity of up to 200MWh. The BESS will cover an area of 4ha and will be located within the authorised substation footprint of the 235MW !Xha Boom Wind Energy Facility.

This proposed amendment letter must be read in conjunction with the EA dated 29 March 2018.

In terms of the Promotion of Administrative Justice Act, 2000 (Act No 3 of 2000), you are entitled to the right to fair, lawful and reasonable administrative action; and to written reasons for administrative action that affects you negatively. Further your attention is drawn to the provisions of the Protection of Personal Information Act, 2013 (Act no. 4 of 2013) which stipulate that the Department should conduct itself in a responsible manner when collecting, processing, storing and sharing an individual or another entity's personal information by holding the Department accountable should the Department abuse or compromise your personal information in any way.

In terms of Regulation 4(2) of the Environmental Impact Assessment Regulations, 2014, as amended (the EIA Regulations), you are instructed to notify all registered interested and affected parties, in writing and within 14 (fourteen) days of the date of the EA, of the Department's decision as well as the provisions regarding the submission of appeals that are contained in the Regulations.

Your attention is drawn to Chapter 2 of the National Environmental Management Act, 1998 (Act No. 107 of 1998) National Appeal Regulations published under Government Notice R993 in Government Gazette No. 38303 dated 08 December 2014 (National Appeal Regulations, 2014), which prescribes the appeal procedure to be followed. Kindly include a copy of this document (National Appeal Regulations, 2014) with the letter of notification to interested and affected parties in this matter.

Should any person wish to lodge an appeal against this decision, he/she must submit the appeal to the appeal administrator, and a copy of the appeal to the applicant, any registered interested and affected party, and any organ of state with interest in the matter within 20 days from the date that the notification of the decision was sent to the registered interested and affected parties by the applicant; or the date that the notification of the decision was sent to the applicant by the Department, whichever is applicable.


