APPLICATION FOR A MINING RIGHT IN TERMS OF SECTION 22 OF THE MINERAL AND PETROLEUM RESOURCES DEVELOPMENT ACT, 2002 (ACT 28 OF 2002): PORTION 38 OF THE FARM ELANDSPRUIT 291 JS, MAGISTERIAL DISTRICT OF MIDDELBURG.

- This serves to inform you that your abovementioned application for a mining right to mine for Coal in respect of the abovementioned property has been granted in terms of Section 23(1) of the abovementioned Act. The Regional Office will prepare the final copies of the right to be signed.
- 2. Take note that the Regional Manager will approve the relevant Environmental Management Program and sign the right.
- 3. Further note that in terms of Section 23(5) of the Act, the mining right comes into effect on the date on which the Environmental Management Program is approved. In terms of Section 25(2)(b) mining activities must commence within one year of the effective date.
- In light of the afore-going, you are requested to:
 - 4.1. Ensure that all outstanding matters regarding your application are finalized and that relevant documents are submitted to the Regional Office no later than 30 days prior to the date mentioned in paragraph 2 above, which outstanding matters include the submission of:

- a. Financial provision in an amount of R 4 104 464.00
- b. the particulars of your authorised representative who will sign
- c. the particulars of the public notary, before whom the right
- d. six copies of the final mining work programme,
- e. diagram prepared by a surveyor (6 (six) originals) in accordance with the requirements of the Mining Titles Registration Act and which shall indicate the following:
 - the north point;
 - the scale to which the plan has been drawn; ii.
 - the name, number registration division and portion of iii. the farm or farms on which the relevant area is situated;
 - the shape of the relevant are in relation to the farm iv. boundaries and co-ordinates points; ٧.
 - the region in which the relevant farm is situated and;
 - be certified, approved signed and dated by the vi. professional land surveyor, unless the Director General otherwise indicates.
 - Three (3) copies of the Social and Labour Plan Vii.
- 4.2 Please make arrangements for the public notary, authorized representative (s) of your company and a witness to be present and attend the signing of the mining right once the aforesaid outstanding matters are verified and an execution date has been finalized by this
- 5. Note further that in terms of section 25(2)(a), the signed/executed mining right must be lodged for registration at the Mineral and Petroleum titles Registration office, Pretoria, within 30 days as from the date of approval of the relevant environmental management programme.
- 6. Failure to comply may result in the withdrawal, suspension or cancellation of the right in question.
