NOTIFICATION OF GRANTING OF ENVIRONMENTAL AUTHORISATION BY DEA

PV Africa Development (Pty) Ltd submitted an application for environmental authorisation to the National Department of Environmental Affairs (DEA) for the construction of four photovoltaic solar energy facilities and associated infrastructure (Zuurwater PV Project Phase 1 – Phase 4) on Portion 3 of the Farm Zuurwater 62 near Aggeneys in the Northern Cape Province.

In terms of Regulation 10(2)(a), the applicant hereby advises registered interested and affected parties that the Department has granted PV Africa Development environmental authorisations for each of the four phases of the project.
