Apologies for the late response as I was busy with exams since last week.

It is clear from the attached documents that the siding was meant for Terra Nominees (BHP)'s mining operations then as well as being the property owner at the time. Mine operations that warranted the need for the subject private siding ceased a while back and the WCFP is the current property owner as per WCFP Trust deeds of trust/founding documents. Granted this, Terra Nominees has no further interest in the subject private siding (despite it still being registered in its name on paper) therefore squarely belonging to the WCFP by as the current property owner.

Given the above, the WCFP can deal with the subject private siding as it deems fit including option 3 as the current property owners.

Should the WCFP wish to revive the private siding for any current or future use, the WCFP will have to register/apply for a new one at own cost.

RE: RAILWAY LINE IN WCFP

Thank you for taking my call just now.

It is good to hear you are doing well in spite of lockdown.

As discussed, I am sending you documentation relating to the railway line in the WCFP – as per attachments. Sadly, it is in a state of disrepair and it has become a serious security issue due to theft of metal plates and wooden sleepers.

The options are:

1. increase the security measures to protect the line
2. upgrade the line so that it is fit for use
3. remove the line

Options 1 & 2 are obviously costly and funding is, as you know, very limited at present.

Consequently, we are in the process of exploring option 3 on the understanding that the line is the property of the WCFP.

We are getting quotes from various service providers to value the metal and remove the line.

We would like to stack the sleepers in the Fossil Park for future use in landscaping and possible building projects, although they also have monetary value so this would depend on what is decided between Trustees, Terra Nominees and SAHRA.

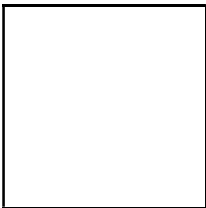
For us to proceed with option 3, we need to be assured that the railway line is the property of the Fossil Park. The attached documentation states quite clearly that it is privately owned by Terra Nominees and we need confirmation that it is part of the land transfer to the Fossil Park. I believe you can assist with clarifying this for us?
