## TAYLORS HALT ARTIST TO PROVIDE EDUCATIONAL TALK ON WATER IN GERMANY

A PIETERMARITZBURG born artist, who is signed under Creative Industry Federation of South Africa (CCIFSA), has been awarded an opportunity of a lifetime in Germany, where he has been invited to provide educational talks on the untold water secrets he learned throughout his ancestral calling journey.

On Tuesday, Sikhumbuzo Dlamini, from Taylors Halt, departed to Gottingen City in Germany, where he will spend twelve days.

This artist, who is also the secretary of CCIFSA, said on Monday he was accompanied by traditional leaders from KwaMafunze area to Msun-

duzi River, where they lit candles and alerted the ancestors about his journey overseas.

Dlamini said his son, who was stabbed to death at KwaPata area, came to him in a form of a dream last year and told him to go to the river to gather his strength by performing a ritual (ukuphahla) and ask everything he wished for

for. "I went to the river and did exactly what he instructed me to do. He died just after acquiring his honours degree in Geography and Environmental Science at the University of KwaZulu-Natal and had a willingness to study further about the relationship between humans and the environment. His spirit inspired me to take his calling further. He used to tell me that he wanted to uplift the community while he was still alive," he said, adding that as Africans we have a deep connection with nature, which is why we have a task to educate other countries.

Dlamini added that the show is going to spark a debate about the importance of water and humans.

"Another thing that it will touch on is ways we can preserve water. There's nothing more important than knowing your identity. Do research and get to know yourself. Don't undermine your God given talents," he said.

**UMGUNGUNDLOVU** District Municipality speaker Nonhlanhla Gabela embarked on a mission to visit clinic facilities to check their conditions and whether they are assisting patients.

Gabela, together with different stakeholders, visited clinics located under uMshwathi Municipality, Msunduzi Municipality and Mkhambathini Municipality.

Speaking about the challenge identified at Embo Clinic in Mkhambathini location, Gabela said there are many employees compared to the patients that utilise this clinic.

"The clinic has about 33 employees and the facility is in a good condition. The only challenge is that few patients utilise it, as it is located far from people's homes which makes it hard for residents to go and do regular

check-ups," she said, adding that it only gets packed on Wednesdays as the doctor is available then. She added that this clinic was built

in 1995 and it operates 24 hours. "The transport to the clinic is

very expensive. A local transport to the clinic costs R25 a single trip. We were all concerned about this issue. Employees do their work, it is just that the community sees themselves living far from the clinic."

"It services three wards, but the attendance from patients is minimal. We will keep tabs on this issue because it was not going to be built if the need for it wasn't identified. We believe that there are people who need clinic services it just that most of them are unemployed," she said.

Gabela added that there are people who need to collect chronic medica-

tion, but are unable to come to the clinic due to not having money.

"We will follow up on this issue and ensure that the clinic functions normally. This facility is of a high quality and any community would be happy to have it."

UMkhambathini Municipality Mayor Nhlakanipho Ntombela said this clinic, situated in Ngilanyoni area, was built long time ago.

"Looking at the place where it was located, the community had a plan to make it a precinct. It is far from people since it is in a rural area. [We are] engaging with the Department of Health, which is going to assist in making the clinic accessible to the people. We need to ask them to organise a bus which will transport patients to the clinic. There needs to be a plan for people to get to the clinic," he said.

The Triple A Beef Feedlot was established in 1981 (prior to the requirement for environmental authorisation) with guidance from the Department of Agriculture and the Department of Water and Forestry at Albert Falls, uMshwathi Local Municipality, Umgungundlovu District Municipality. The onsite abattoir was established in 2001 under environmental authorisation granted EIA/1429.

An application for the environmental authorisation of expansion of the feedlot and abattoir facilities and infrastructure in terms of section 24G read with s24F of the National Environmental Management Act, 1998, has been made. The EIA listed activities for which condonation is sought include:

- expansion of the feedlot through the construction of new pens, activities 4(i) and 39(i);

  expansion of waste water maturation ponds, activity 56.
