**NOTICE IN TERMS OF SECTION 136 (1) OF THE FIREARMS CONTROL ACT, 2000 (ACT NO. 60 OF 2000)**

By virtue of the powers vested in me by section 136(1) of the Firearms Control Act, 2000 (Act No. 60 of 2000), I Mangwashi Victoria Phiyega, National Commissioner of the South African Police Service, in my capacity as Registrar of Firearms as contemplated in section 123 of the said Act, hereby give notice that the State intends to destroy all firearms, ammunition as well as firearm parts that were voluntarily surrendered to or forfeited to the State. For a list of firearms intended to be destroyed by the State, interested parties may visit the South African Police Service's website at <http://www.saps.gov.za>

In terms of section 136(2) of the Firearms Control Act, 2000, any person who has a valid claim to such firearm or ammunition or firearm parts may, within 21 days after the date of publication of this notice, make representations to me as to why such firearms or ammunition or firearm parts should not be destroyed. The representations must contain full information of the firearm, the owner of the firearm, and the police station where the firearm, the firearm parts and ammunition were voluntarily surrendered or forfeited. Any such representations must,
