MINING RIGHT APPLICATION on Farm Klein Rivier 713 Ptn 32 and Farm Buffelsbosch 742 Ptn 14 situated in the District of Humansdorp (Eastern Cape Province)

Please register me as an interested and affected party in respect of the above application.

I shall answer the questions below as best as I can with information presently available. However two important aspects need clarification. Kindly deal with these as soon as possible. These aspects impact directly on the merits of the application as environmental issues:

1. A huge volume of material stands to be mined. Given the area of proposed actual mining and the depth of the excavation, some 5 million cubic metres of rock may be mined. To indicate the desirability of the project, please advise for what specific purpose the material will be mined; - I would have to confirm this with the applicant but I assume the quarry will serve primarily to provide stone for the construction of the nuclear power station. If for some reason the power station construction did not go ahead, then I imagine the need for the quarry in this area would be reduced and the applicant may amend the right to much smaller volumes and production rate to serve as commercial quarry – That aspect will be sorted out on my next site visit to the applicants.
2. Bearing in mind the existing road infrastructure and the shortcomings thereof, whereto and along what route will the mined material be transported? This may have road safety consequences dust generation and similar negative impacts that may need to be commented on. – That is definitely one of the issues which could represent significant impact and will have to be properly addressed in the EIA and EMP
3. The mining are could be in close proximity to the aquifer that is generally associated with the Sand River and the wetlands on that portion of Buffelsbosch. Has any determination of this been made, or will it be undertaken as part of the EIA? You are correct. Such study will be undertaken as part of the EIA.

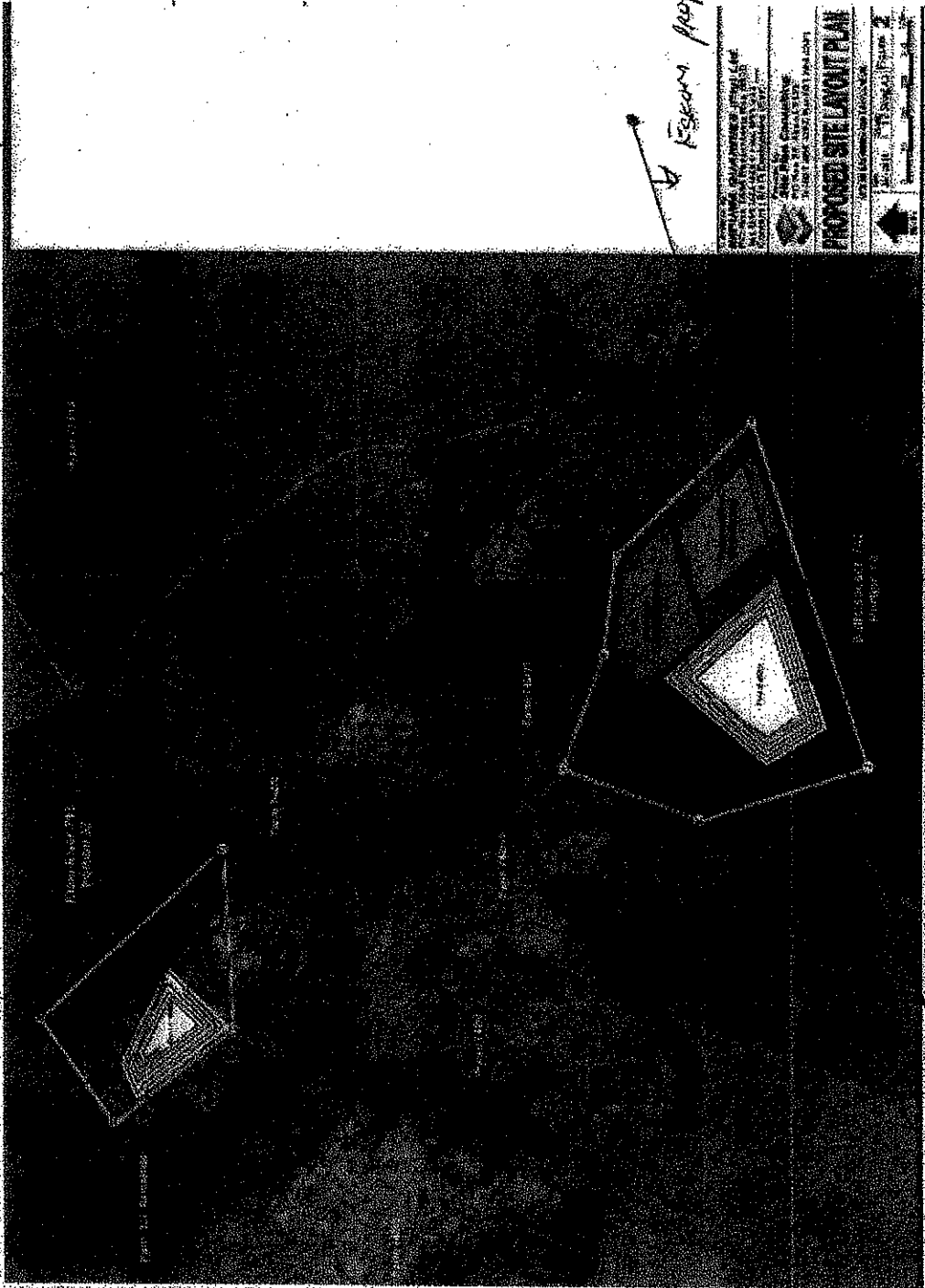

The St Francis Kromme Trust is an environmental NGO based in St Francis Bay.

The Trust notes the application to mine rock and aggregate on the two sites located on farms south of the St Francis-Oyster Bay road and the BID's assessment that "the animal life around the affected area will be temporarily chased away by the presence of such activities" as drilling, blasting and crushing. The BID goes on to say "There is a vast expanse of similar habitat type around every proposed activity area and it is unlikely that any impact on animal life will occur from the proposed activities." (pages 13 and 14).

The Trust advises that the coastal plain between Tsitsikamma and PE is one of the most important areas in the country for Denham's Bustard and White-bellied Korhaan, and both species are found in high density on the particular stretch of land proposed for these mining activities. These bird species are highly selective about habitat and there is not, in fact, a vast expanse of similar habitat around the area. The concentrations of Denham's Bustard, in particular, that are found in this location are not seen anywhere else. What effect will blasting have on the well-being of this species? And what effect will these activities have on the White-bellied Korhaan, a species notoriously sensitive to human activity? The Humansdorp population of these birds is virtually isolated from the rest of the country, making it extremely important to protect.

It is essential that an assessment of the impacts specifically on the bird population be included in the environmental assessment.

As to land developments that may be impacted upon by the proposed development, it is assumed that the applicant is aware of the wind farm to be constructed in this area.

I shall answer the questions below as best as I can with information presently available. However two important aspects need clarification. Kindly deal with these as soon as possible. These aspects impact directly on the merits of the application as environmental issues:

1. A huge volume of material stands to be mined. Given the area of proposed actual mining and the depth of the excavation, some 5 million cubic metres of rock may be mined. To indicate the desirability of the project, please advise for what specific purpose the material will be mined; - I would have to confirm this with the applicant but I assume the quarry will serve primarily to provide stone for the construction of the nuclear power station. If for some reason the power station construction did not go ahead, then I imagine the need for the quarry in this area would be reduced and the applicant may amend the right to much smaller volumes and production rate to serve as commercial quarry – That aspect will be sorted out on my next site visit to the applicants.
2. Bearing in mind the existing road infrastructure and the shortcomings thereof, whereto and along what route will the mined material be transported? This may have road safety consequences dust generation and similar negative impacts that may need to be commented on. – That is definitely one of the issues which could represent significant impact and will have to be properly addressed in the EIA and EMP
3. The mining are could be in close proximity to the aquifer that is generally associated with the Sand River and the wetlands on that portion of Buffelsbosch. Has any determination of this been made, or will it be undertaken as part of the EIA? You are correct. Such study will be undertaken as part of the EIA.

As a response to your invitation to comment I wish to comment on a few aspects, some of which were actually raised at the time of my registration as I & AP:

1. The **desirability of the project** has to be considered in any application that will have an impact on the environment. You have indicated that the obvious use of material will be associated with the envisaged power plant at Thyspunt;
2. **Impact of transport** several million cubic metres will have to be transported. The transport of this nature has a severe impact on road surfaces, traffic safety (dust generation) and some other less obvious or serious impacts;
3. **Groundwater:** a significant aquifer is located in the general area. This source has not yet been fully evaluated but it is submitted that special steps should be taken to determine the precise location relative to the proposed works and to ensure that it will not be polluted or otherwise compromised.
