#### **Purpose of the meeting**

The meeting was a follow up to oversee the progress regarding June Hosford recommendations on the Broster Beads Collection. SAHRA wanted to check what the University did as far as the implementation of the recommendations is concerned. Before going to Walter Sisulu I had a meeting at East London Museum and I also attended an opening of the indigenous Games Exhibition.

#### Background

The South African Heritage Resources Agency (SAHRA) requested June Hosford to conduct a conservation assessment of the Joan Broster Beadwork and Clothing

Collection which forms the major part of the special collections, hosed in the Library building at the Walter Sisulu University.

#### Discussions

#### Meeting at the East London Museum.

Before going to Walter Sisulu University, I had to attend a meeting and an opening if the exhibition at the East London Museum in East London. The meeting was still about the Walter Sisulu Collection and also to check if there were any developments since SAHRA's visit. Due to the opening of the indigenous games exhibition I could not meet with Mr. Magadla, he assigned Mr. .... who is the Museums conservator to meet with me. Fortunately Mr. Dion Smit is so familiar with the Broster Bead Collection and he mentioned that it is urgent that it must get a proper storage before it's too late. Mr. Dion Smit showed me the storage of their Museum and he stated that it can be a good example of storage for the Broster Beads Collection.

Mr.Smit further stated that as long as the Walter Sisulu University is not approaching them to say they are ready, then the Museum will not be able to do anything at this stage.

#### **Opening of the Indigenous Games Exhibition.**

This is a very nice exhibition and it also reminded me f the games that I used to play while I was young. Nowadays Children are no longer playing these games because of new technology.

I have established that Mr. Magadla did meet with Mrs Luso in Umtata in this regard. According to East, at the meeting Mr. Magadla stated that they are ready any time to assist the Walter Sisulu University.

#### Meeting with Mrs Luso at WUSU.

SAHRA wanted to check developments following June Hosford recommendations on the Broster Beads Collection. Mrs. Lusu stated that one of the critical aspects of their endeavors in safeguarding the collection is to find a proper space and building to house the artifacts. SAHRA understands that there were MDA Architects who came to the University to present a Building Plan. This was after the University promised to make some funding available for a new building for the Broster Beads Collection, however the funding never materialized to date.

It was mentioned that on 07 February 2011, a meeting of the Senate Library and Information Services Committee was held. The purpose of the Meeting was to provide an update on the status of the Joan Broster Beadwork project, a full report of the meeting is available.

Mrs. Lusu visited the Rhodes Lorrie Library to see the Museum there. Mrs Lusu saw the Museum there as the good example for the Walter Sisulu University to house their collection. The architects who came at WUSU to present a building plan were asked to also ago and view the Rhodes Lorrie Library so that they will be able to see exactly the ideal building that the University would like to have for their collection. Mr. Magadla did meet with Mrs Luso at the Mthatha Museum to discuss the assistance that the East London Museum is willing to Give to the Walter Sisulu University.

Mrs Danster who is the Director of Library and Information Services met with the Deputy Director of the East London Museum about the Lottery funding. The East London Museum built a very nice storage for their collections and was funded by the National Lotteries Board. The East London is assisting WUSU to write a proposal so that they can also secure the funding for the Broster Beads Collection. On 30 March 2011 the SAHRA Permit Committee suggested that SAHRA must

assist WUSU to write a proposal to the National Lotteries Board. This happened after the Heritage Objects reported on the recent visit to WUSU.

Mrs Lusu also stated that in as much as they have implemented some of the things that June suggested, without a proper funding they cannot implement some of the things recommended by June Hosford. She was referring to the Control Temperature system that is very expensive. The University also promised that there will be another Building at the University that will be sacrificed and be available to house the Broster Bead Collection. The Building used to be a restaurant at the University and is currently not in use after the restaurant was closed down.

SAHRA was also interested in finding out if they are researchers that are using the collection for research and Mrs Lusu confirmed that indeed there were researchers who were using the collection for research purposes. However this was later closed due to the fact that there was no policy as far as researching the collection is concerned. The interest in the collection is worldwide because according to Mrs Lusu there are even people from German who phone at times ask about the collection.

SAHRA was also interested in knowing about the cleaning of the storage that houses the Broster Bead Collection. Mrs Lusu confirmed that they do clean once a month and they guided by the June Hosford recommendations when they doing the cleaning. Mrs Lusu suggested that once again SAHRA should write to the Management of the University and let them know how serious the collection is.

#### **Issues emerging from the discussions**

Mrs Lusu suggested that once again SAHRA should write to the Management of the University and let them know how significant the collection is. One of the things emerging from the discussion I held with Mrs Lusu was the fact that the University has other priorities of paramount importance than the safeguarding and conservation of the Broster Beads Collection. I am satisfied and very happy with Mrs Lusu's and Mrs Danster efforts to persuade the University on getting on board. I'm not happy with the fact that the there is still a lot to be done as far as June Hosford's recommendations are concerned and the Management of the University has not taken Mrs Luso and Mrs's Danster efforts seriously.

#### **Conclusion.**

It was concluded that the Walter Sisulu University is in a process of trying to secure a lotto funding in this regard.
