Dear Dr Gommery, Mr. Kgasi and Dr Brink,

Thank you for your permit application to excavate at Brad Pit karstic complex, Milo Caves karstic complex, Waypoint 160 and Bridge Cave, as well as for the continued preparation of the backlog from Alcelaphine Site, Femur Dump, Unati & Mpho Pit A, Unati & Mpho Pit B and X Cave on Bolt's Farm, Sterkfontein 173 IQ (portion 32), within the Cradle of Humankind World Heritage Site.

Before SAHRA will issue a permit, the following items must be addressed in the proposal:

- 1. In the application it is stated that so far, not enough *in situ* geology is exposed at Brad Pit B to consider real sitemanagement. SAHRA does not support this statement.
- 2. All sites must be tarped with a heavy-duty PVC coated, sun-proof textile and secured by sandbags at all times outside of the field season to avoid cracking and destabilisation.
- 3. Excavation wall edges of deep excavations must be capped with cement to reduce erosion.
- 4. No excavation should take place below unstable areas.
- 5. Permanent pathways into pit must be established.
- 6. Please elaborate on the sentence "The fossiliferous blocks of breccia are grouped into a specific dump."
