Excavations are proposed to take place at Brad Pit A (SW corner); Brad Pit B (E and S corners); Waypoint 160 (main entrance, remove dump); Milo A (W side); Milo B (N side) and Bridge Cave (exposed material of the "Panthera spot" of the "Panthera infill"). It is noted that, because of the risk of degradation due to rainfall, Prof. B. Kuhn and his wife, both experienced speleologists, will be in charge of the Bridge Cave excavation. It is understood that the Femur Dump will not be excavated but maintained only. Previously excavated X Cave material will be analysed for fossils and sterile breccia blocks will be discarded.
