# Application for Environmental Authorisation for a prospecting right on the Remainder, Portion 1 and Portion 16 of the farm Jagersfontein 14, Fauresmith District, Free State

The application entails a prospecting right for diamonds by Jagersfontein Developments (Pty) Ltd on the Remainder, Portion 1 and Portion 16 of the Farm Jagersfontein 14 IS, Fauriesmith District, Xhariep District Municipality, Free State. Invasive activities include drilling and sampling, followed by bulk sampling. A Scoping Report, draft EIA and EMP, and Heritage Impact Assessment (HIA) were submitted with the application: Phillip, L. 2009. Phase I Impact Assessment of the Dormant Jagersfontein Mine (Free State) in terms of Archaeological and other Heritage Sites. In an interim comment dated 28 September 2018, SAHRA rejected the HIA and required a full, valid HIA inclusive of a desktop Palaeontological Impact Assessment to be conducted by suitable a professional heritage practitioner, respectively. A final EIA and EMP was submitted on 12 October 2018 without referring to the SAHRA comment and without providing the requested HIA and PIA, which is why SAHRA recommended in a final comment from 1/11/2018 to refuse the proposed activities. Subsequently, the applicant submitted a HIA and amended draft EIA and EMP to the application.



Recommendations:

Several other sites of significance were identified within the larger prospecting rights application area and these should be mitigated as per the recommendations included.

Should the client decide to alter the size or location of any of the prospecting core areas (P1 - P4) the new areas should be subjected to a field based HIA before any work can commence.

A previous PIA of the area indicated that there is negligible possibility of finding any palaeontological deposits within the area (Rossouw, 2013).

In an interim comment from 14/3/2019, the referenced PIA by Rossouw (2013) was requested to be submitted and was uploaded subsequently.


ROSSOUW, L. 2013. EXEMPTION OF A PHASE 1 PALAEONTOLOGICAL IMPACT ASSESSMENT FOR A PROPOSED PIPELINE ON SUBDIVISION 16 & REMAIN EXTENT OF THE FARM JAGERSFONTEIN NO. 14, KOPANONG LOCAL MUNICIPALITY, FREE STATE PROVINCE.

The author recommended an exemption from further palaeontological studies for a pipeline installation in a section in the SE corner of the proposed area.

The underlying geology consists of shales of the Tierberg Formation (Ecca Group, Karoo Supergroup) that may contain fossils such as fish scales, sponge spicules and, quite commonly, trace fossils. They are mantled by Quaternary-aged channel fills and sheet-wash deposits, including unconsolidated wind-blown sands and limited alluvium from the nearby Prosesspruit. Overbank deposits and alluvial terraces of large river courses such as the nearby Riet River have previously yielded numerous Quaternary vertebrate fossil remains.

#### Interim comment

The SAHRA Archaeology, Palaeontology and Meteorites (APM) Unit cannot accept the Letter of Exemption (Rossouw, 2013) as it speaks to a different, less invasive activity than the drilling, sampling, and bulk sampling


