Jagersfontein Developments (Pty) Ltd submitted an application for prospecting for diamonds on Subdivision 1 (Kings Paddock), Subdivision 16 and the Remaining Extent of the Farm Jagersfontein 14 (excluding tailings dumps), Fauresmith District, Xhariep District Municipality, Free State Province. Proposed invasive activities include test drilling and excavation as well as bulk sampling (large diameter drilling and or excavations).
