### Please be advised as follows:

- 1. It was noted that as per the site plan drawing provided there is an existing swimming pool and ablutions within the premises, you are required to provide photographs of the ablution and swimming pool.
- You are also required to provide approved drawings for the pool shown as existing on the site plan provided, alternatively prove that the pool was constructed before the house turned 60 years old.
- 3. If there is none available, you are required to do a form I application and an applicable fee of R3 200 should be paid if there is no new work proposed.
- 4. Internal photographs of the house and contextual photographs should be provided.

Written responses/requests for reconsideration of the application or consideration of new information must be loaded to the case on Sahris.

Required additional information or revised drawings must be submitted within <u>six months</u> from the date of this letter or the application will lapse, and a new application will be required.
