Located on Portions 2870296 of the farm Mooiplaats 367JR, in the Mooiplaats area (east of Pretoria) of the Greater Tshwane Municipality in Gauteng. The sites, as well as a historical water furrow, will be impacted by the development of the Mooiplaats Educational Facility on the land parcel. The LIA sites will be excavated & mapped in detail, while the water furrow will be mapped and recorded in detail before demolition.
