Interim Comment

IN TERMS OF SECTION 38 OF THE NATIONAL HERITAGE RESOURCES ACT (ACT 25 OF 1999) AND SECTION 37, 41 OF THE KWAZULU-NATAL AMAFA AND RESEARCH INSTITUTE ACT (ACT 05 OF 2018)

Attention: Olde World Foundry AEL application (Submittal ID: 340)

Olde World Foundry is applying for an Atmospheric Emission License in terms of Section 37 and Section 22A of NEM: AQA. The application was submitted on the South African Atmospheric Emission Licensing & Inventory Portal on 12 August 2021 (Submittal ID: 340). The National Environmental Management: Air Quality Act, requires AEL applicants to bring their applications to the attention of relevant organs of state, interested persons, and the public.

The Heritage Officers Committee meeting considered the application on the 9th of February 2021. The committee noted that the work had been done on-site and, no previous decisions or comments from Amafa and Research Institute were found. The committee also noted that the Old World Foundry is fully developed and operational, however, the application for development in terms of Section 41 of the KwaZulu-Natal Amafa and Research Institute Act no. 05 of 2018 was not found as well.

The applicant is required to provide the previous Environmental Impact Assessment report that includes Amafa and Research Institute comments or submit a form I for the failure to apply in terms of Section 37 of the KwaZulu-Natal Amafa and Research Institute Act no. 05 of 2018.

Failure to comply with the requirements of the National Heritage Resources Act and the KwaZulu-Natal Amafa and Research Institute Act could lead to legal action being instituted against the applicant.
