Additions and alterations to existing house on Portion 10 of ERF 2102 of Durban, at 18 Pinsent Road, Essenwood, Durban 4001 The existing roof space has been altered and converted to a TV room, new Bedroom 3 & en-suite. A new timber staircase provides access to the converted attic. Replacement of all existing steel windows with new timber framed and bricking up two of the existing timber doors is proposed.

We acknowledge receipt of your application for a permit to carry out work on the above property on 25 March 2013 Amafa reviewed the application on the 09 April 2013.

Please be advised as follows:-

- (1) Amafa was unable to consider the merits of the application as the work had already commenced, alternatively, has been completed;
- (2) As a result, a permit cannot now be issued;
- (3) We would like to draw your attention to the fact that your failure to obtain a permit prior to the commencement of the work, is in contravention of the provisions of the KwaZulu-Natal Heritage Act (4 of 2008), and as such is a criminal offence for which you may be prosecuted;
- (4) However, Amafa has decided to condone your failure to obtain a permit, as required, on condition that the work was conducted strictly in accordance with **ElliAr arch.drawing services drawing no 1/1, dated 07/03/2013, received by Amafa on 25/03/2013**, and that all the work shown on the application is completed within by 25/06/2016.
- (5) **Prior written approval from Amafa is required for any deviation to the approved plans.**
- (6) No legal action will be instituted against you in this instance.

and that a permit must be obtained prior to any work being conducted in the future. Failure to do so is a criminal offence that is punishable by a term of imprisonment or a fine, or both. The property may also be forfeited to the state. Furthermore, a moratorium may be placed on any development on the property.
