UNAUTHORISED ADDITIONS AND ALTERATIONS: Portion 57 of ERF 935 Durban North, being at 42 St. Kilda Avenue, Durban North

We acknowledge receipt of your application for a permit to carry out work on the above property. The KZN Amafa and Research Institute (the Institute) reviewed the application on the 25 October 2022.

Please be advised as follows:-

- (1) The Institute was unable to consider the merits of the application as the work had already commenced, alternatively, has been completed;
- (2) As a result, a permit cannot now be issued;
- (3) We would like to draw your attention to the fact that your failure to obtain a permit prior¬ to the commencement of the work, is in contravention of the provisions of the KwaZulu-Natal Amafa and Research Institute Act (5 of 2018), and as such is a criminal offence for which you may be prosecuted;
- (4) However, the Institute has decided to condone your failure to obtain a permit, as required, on condition that the work was conducted strictly in accordance with T.C.(D.G.S.C. Design) Drawing no.: LND-SUB-01, 19 August 2022, received by the Institute on 25 October 2022, and that all the work shown on the application is completed within a calendar year of the date of this letter.
- (6) Prior written approval from the Institute is required for any deviation to the approved plans.
- (7) No legal action will be instituted against you in this instance.
