## UNAUTHORISED ADDITIONS AND ALTERATIONS: Erf 7936, being at 533 Esther Roberts Road, Glenwood, Durban

We acknowledge receipt of your application for a permit to carry out work on the above property. The KZN Amafa and Research Institute (the Institute) reviewed the application on the 28 November 2022.

Please be advised as follows:-

(1) The Institute was unable to consider the merits of the application as the work had already commenced, alternatively, has been completed;

(2) As a result, a permit cannot now be issued;

(3) We would like to draw your attention to the fact that your failure to obtain a permit prior¬ to the commencement of the work, is in contravention of the provisions of the KwaZulu-Natal Amafa and Research Institute Act (5 of 2018), and as such is a criminal offence for which you may be prosecuted;

(4) However, the Institute has decided to condone your failure to obtain a permit, as required, on condition that the work was conducted strictly in accordance with D.K.C. Designs drawing no.: S2022-Jun-4A 1of 1, received by the Institute on 28 November 2022, and that all the work shown on the application is completed within a calendar year of the date of this letter.
