- The committee had noted that previously approved plans which had been required were not provided as the applicant had only provided only the first drawing for the erected structure on site and had not provided changes to the structure for previous years.
- The committee noted that if there had been any alteration to the exterior walls of the main structure the internal spaces to the house were also affected which internal photographs are required.

 failure to provide required items a separate form I application with a fee of R4000 and
 accompanied with drawings is required.
- Internal photographs are required.

Public Participation: the applicant will be notified of the level of public participation required and will have to bear the costs thereof. Neighbours, Ward Councillors, and Heritage Societies should be consulted in the case of demolition & development applications. Owners & residents of properties within 100m must be consulted for demolition applications. All documentation submitted is retained for record purposes and interested and affected parties may apply to view the documentation.

Written responses/requests for reconsideration of the application or consideration of new information must be loaded to the case on Sahris (email khanyi.zondi@amafainstitute.org.za) within 30 days of the date of this letter or any requirements/decisions contained herein will be considered final. Extensions of this time frame can be requested upon receipt of motivation.

Required additional information or revised drawings must be submitted within <u>six months</u> from the date of this letter or the application will lapse and a new application will be required.
