- The committee had noted that the applicant had not completed the application form, the applicant had to provide his evaluation of the property on page 2 in order to provide his/her assessment on the significant of the structures on site.

Further requirements

The committee require previously approved plans e.g., all plans which had been done on the
previous years and were submitted to the council or to the Institute (KZNARI) for an approval,

failure to provide required items a separate form I application with a fee of R4000 and accompanied with drawings is required.

- The committee require internal photographic images of the building which will be demolished.
- The committee required that the applicant to complete page 2 of the KwaZulu-Natal Amafa & Research institute Form which would assist with assessment from the applicant findings.

Public Participation: the applicant will be notified of the level of public participation required and will have to bear the costs thereof. Neighbours, Ward Councillors, and Heritage Societies should be consulted in the case of demolition & development applications. Owners & residents of properties within 100m must be consulted for demolition applications. All documentation submitted is retained for record purposes and interested and affected parties may apply to view the documentation.

Written responses/requests for reconsideration of the application or consideration of new information must be loaded to the case on Sahris (email khanyi.zondi@amafainstitute.org.za) within 30 days of the date of this letter or any requirements/decisions contained herein will be considered final. Extensions of this time frame can be requested upon receipt of motivation.

Required additional information or revised drawings must be submitted within <u>six months</u> from the date of this letter or the application will lapse and a new application will be required.
